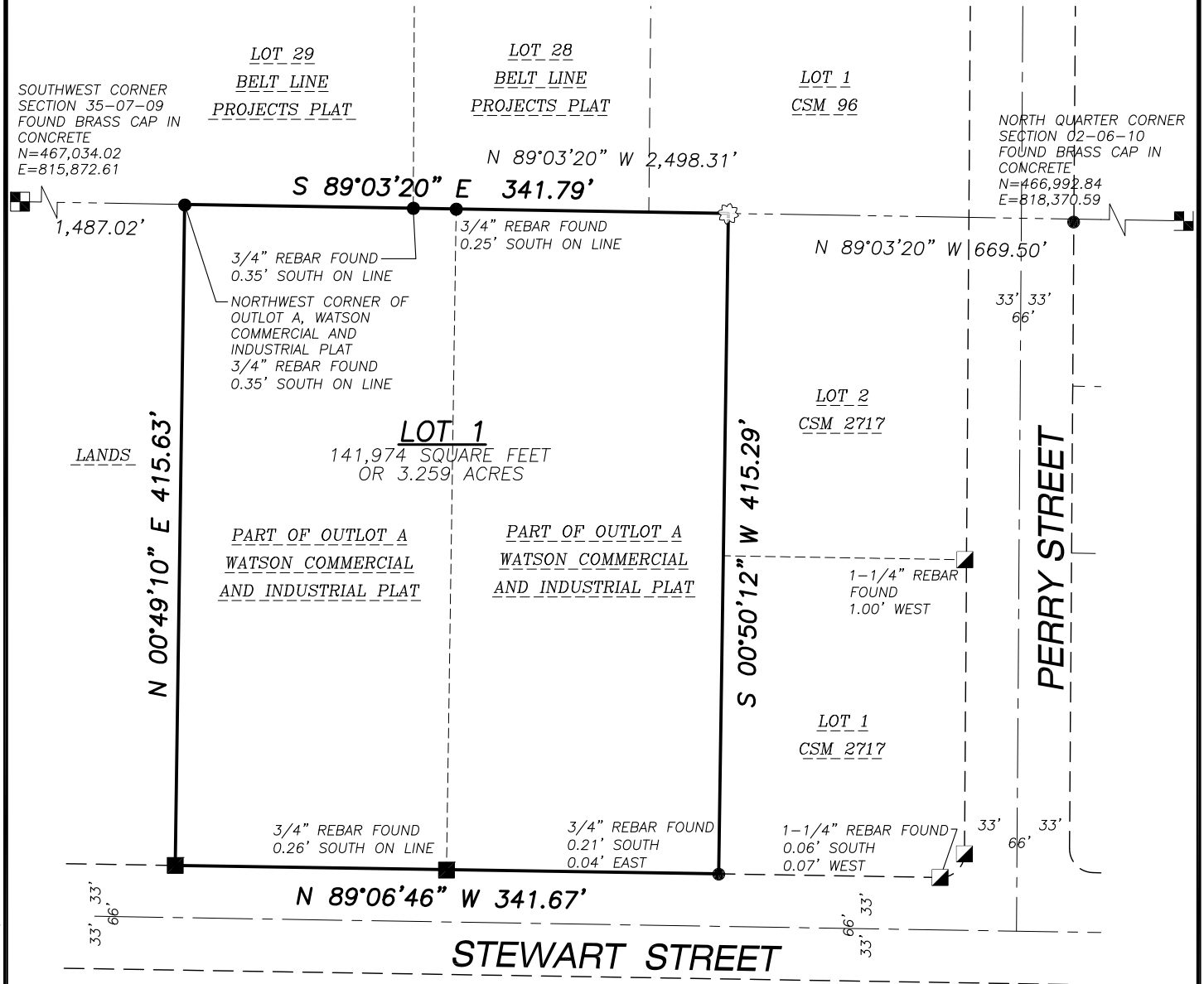

RANGE 10 EAST, CITY OF MADISON, DANE COUNTY, WISCONSIN

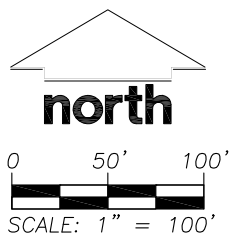
