1. CALL TO ORDER / ROLL CALL

The meeting was called to order at 5:00 p.m. by Bert Zipperer in the absence of the chair.

2. METROPOLITAN MILWAUKEE FAIR HOUSING CENTER PRESENTATION ON TESTING FOR HOUSING DISCRIMINATION

Tobi LeMahieu was present to provide information on the Metropolitan Milwaukee Fair Housing Center. She distributed brochures.

Commissioner Nia Enemuoh Trammell arrived at 5:04 p.m. and assumed the chair.

LeMahieu reviewed programs offered by the Center including enforcement, outreach and education, fair lending and inclusive communities. She described the testing program.

The Center performed 20 tests in 2009 in Madison. The number dropped statewide in 2009 from about 300 to 250. Housing discrimination is generally

under reported and undetectable.

The Center also conducts systemic testing in communities to determine if discrimination is occurring. The top 3 types of discrimination reported are race, disability and familial status. In Madison, discrimination based on disability surpassed race discrimination.

The Center has a contract with the City of Madison through the Community Development Block Grant Office to perform testing and conduct rental management training. If the Center is not going to have enough individual tests to meet its City contract, it does systemic tests.

LeMahieu indicated the Center would be interested in renewing its working relationship with the Madison Equal Opportunities Division for complaint referral. Commissioners expressed interest in further discussion of this topic.

Morrison stated that poverty drives people to take what they can get. Testing can make it harder for people to find affordable housing. He stated that his experience with the Latino community is that there is so much distrust of government agencies and other institutions. He advocated that aggressive education of landlords and people in poverty is what gets people into housing.

Enemuoh-Trammell indicated that this would be a topic for on-going discussion.

A motion was made by Morrison, seconded by Benford, to Accept the recommendation of the EOC Executive Committee to propose that the City adopt a policy allowing City employees to use paid leave to donate organs or bone marrow and that the change be designated to honor the memory of Dr. Anthony L. Brown, former Director of the Equal Opportunities Commission. The motion passed by voice vote/other.

Nuñez informed the Commission that the Common Council will act on a resolution honoring Dr. Brown at its next meeting.

This is the first step in a long process to obtain approval. Nuñez will first contact Human Resources, Labor Relations and other appropriate City contacts before introducing anything to the Common Council. It was agreed that at the appropriate time, Commissioners Enemuoh-Trammell and Zipperer will reach out to the family to make them aware of the proposal.

12. <u>17878</u> Discussion regarding returning to the full Commission review of cases on appeal

The EOC Executive Committee has requested that the full Commission discuss this issue prior to their making a recommendation for action.

The EOC President will summarize meetings attended and other related activities on behalf of the Commission since the last Commission meeting. For information only. Any item raised for future discussion will be posted on the next agenda.

Enemuoh-Trammell reported that she has been reaching out to individuals to encourage them to apply for membership on the Commission. She encouraged other Commissioners to do the same.

A new item that she will ask the Executive Committee to examine is the City's use of eminent domain. She stated that she has been contacted relative to the CDA's use of eminent domain. There have been allegations that historically it has had a disparate impact on people of color.

In order to better organize the EOC Executive Committee agenda, if an individual introduces a new agenda item, they will be asked to take lead responsibility for the item. She wants individuals to take ownership of issues. If an individual does not have time to take on this responsibility, they need to tell Enemuch-Trammell so that she can find another individual to accept lead responsibility. Discussion relative to prioritizing Executive Committee items will be placed on the next Commission agenda for discussion.

Enemuoh-Trammell has been in contact with Mitch at the UW Law School. He has indicated that he wants to work with her on a Pro Se Manual (for unrepresented complainants and respondents). He has a new group of students starting in May that can work on the project. She will request an opinion from Assistant City Attorney Adriana Peguero about whether the Commission can create the manual and if there are limitations on the content of the manual.

Enemuoh-Trammell is looking for Commissioners to assist as editors. Harrington, Morrison and Zipperer volunteered to assist.

Enemuoh-Trammell provided a flyer on the UW clinic to distribute to complainants and respondents.

Enemuoh-Trammell stated that she may consider assisting in training and working with the students at the Clinic in preparing cases. If she does so, she would have to resign from the Commission.

14. <u>17832</u> DIRECTOR'S REPORT- For information only. No action required.

Lucía Nuñez, DCR Director, will report on the following:

Lucía Nuñez reported that she contacted the City Attorney to see if there is anything in the works to draft an ordinance regarding penalties for parents of out of control children, as requested at a previous meeting. The City Attorney has received no request to draft such a proposal.

The Commission on People with Disabilities has asked that an ordinance be drafted to set a goal for new construction of public housing for 10 percent to be fully accessible. The current standard is 5 percent.

That Commission is also working with Emergency Management on issues relating to special needs populations. There is discussion of an on line registry. The registry would be used in the case of a natural disaster or other times when a community-wide emergency exists.

The Affirmative Action Commission has completed training on conducting appeals. It is anticipated that a number of appeals will be considered in April.

Nuñez thanked the Commission for passing the coverage for genetic identity.

15. <u>12507</u> COMMON COUNCIL UPDATE--For information only. No action required.

Ald. Brian Solomon will provide an update on Common Council actions since the last Commission meeting.

In Ald. Solomon's absence, Zipperer reported that the ordinance amendment allowing Commissions staffed by the DCR to introduce ordinances and

resolutions was considered by the Common Council. Although the proposal failed, the vote was closer than expected. Nine members of the Common Council voted in support of the proposal (Aye: Eagon, Solomon, Rhodes-Conway, Kerr, Palm, Cnare, Verveer, Bidar-Sielaff and Rummel; No: Skidmore, Schmidt, Bruer, Compton, Clausius, Schumacher, Clear, Pham-Remmele, Sanborn, Maniaci and King). Zipperer stated that he was questioned for 40 minutes.
