Paul Kusuda disclosed that he serves on the Dane County AAA. Kathleen Poi serves on the Board of the West Madison Senior Coalition.

REPORTS

1. 43424 Madison Senior Coalitions Report

Madison Senior Coalitions, Jim Krueger, North Eastside Senior Coalition Krueger reported that the Coalitions have hired a lawyer to prepare documents for the consolidation of the Coalitions. Executive Directors and staff have formed teams to review and prepare policies and procedures for programs and services. These planning subgroups are organized around: 1) administration, Board & committee structure and bylaws; 2) financial structures and fund raising; 3) data base development for case management services; and 4) HR regulations, staffing, salaries.

Kaud and Canfield attended the North Eastside Senior Coalition membership meeting and shared their observations. Concern was voiced that programs at Warner Park might be lost. Poi commented on the Westside Senior Center change to delivering programs in local community and targeted locations (taking programs to people).

2. 48103 Community Services Committee, Donna Bryant

Bryant reported on the \$2.5 million dollars of requests for approximately \$1.6 million available in the CSC budget. An additional amount is available in the Emerging Opportunities Program funding from the City of Madison. Committee members listened to the agencies present their programs. Staff will make 14-16 recommendations to the committee for \$146,000. Committee members learned that fledgling programs can use a fiscal agent, reducing barriers to applying for funds.

Verveer gave an update on the City budget. Kusuda's request for an additional senior position was considered by the Mayor, but not funded. Appreciation for Kusuda's effort was voiced by committee members. Some discussion ensued about the future for the Coalition collaboration, and perhaps, the Senior Center's role in the delivery of programs and activities.

ACTION ITEMS

5. 49265 CoA Meeting Time Change

Committee members respected a conflict for Alderperson Verveer and agreed to delay their starting time to 2:30 pm, beginning with meetings in 2018. Passed unanimously on the motion of Canfield and Ferington.

6. 49266 Renewal Terms for CoA Members

Beatty reported that Whitt and Bleason agreed to renew their terms on the committee. After discussion at the meeting, Sherman also agreed to be renewed. Beatty will connect with Allgood regarding her wishes.

ADJOURNMENT

Verveer and Ferington congratulated Beatty for her award as LGBT Ally of the Year at the OutReach, Inc. 25TH Anniversary Banquet.

Being no more business, the meeting was adjourned at 3:05 pm on the motion of Rimkus and Canfield.
