6 Special Presentation - Integrated Pest Management Experts

"IPM Basics and Benefits" - Thomas Green, Director - Integrated Pest Management Institute of North America

Discussion focused on the following topics:

- Online learning and/or other ways to engage city agencies, etc
- Communities have compiled lists of products/methods that fit certain profiles e.g. organic, low-risk, etc. e.g. San Francisco has a 4-tier system that has been adopted by the Green Building Association
- Organizations, besides the EPA, that review pesticides.
- Issues that can affect pollinator habitat outside of pesticides, e.g. clearing tick habitat also removes habitat that is suitable for pollinators

7 Integrated Pest Management Policy - Survey Review

The draft survey under consideration was offered by the Pollinator Protection Work Group after a detailed review of the current IPM policy; Task Force requested that it should also explore what pests are being encountered and what ways are being used to manage them other than pesticides and suggested that the request to complete the survey be sent from the Mayor's Office. Further discussion explored adding and editing certain questions before, in the interest of time, members were asked to send additional input to staff by the end of the week. A revised draft of the survey will be reviewed by the Task Force at its next meeting on November 26th. Staff will provide a list of agencies that have been filing IPM reports.
