Head Start and Early Head Start funds are used to support these programs (portion of salaries, child/family services and portion of co-pays)

2010 Budget = \$481,195.

2010 City funding = \$36,062 or 7.5% of budget

GBVR receives \$5,529 in EHS and is applied as parent copays

Preschool Enrichment Program

2010 Budget = \$137,144

2010 City Funding = \$40,060 or 29% of budget
