Preface This is a new event request for Warner Park. The first-year attendance projection is up to 500 throughout the course of the event.

STAFF RECOMMENDS APPROVAL BASED UPON THE ORGANIZER'S AGREEMENT TO THE FOLLOWING TERMS:

1. Aldermanic notification.

COMMISSIONERS

- 2. All park applications, permits, event deposits, insurance and fees will be reconciled and on file in the Park office at least one week prior to the event, file at least one week before the event, including the.
- 3. Organizer will schedule an on-site meeting with the East Parks Supervisor for site plan review. Organizer will agree to implement specific recommendations made by the Supervisor.
- 4. Sponsor has reviewed the City of Madison Special Event related policies and procedures, will assume the responsibility of their conveyance to the event participants, and will assure the Parks Division that they will be upheld., including the provisions for an enclosed beer garden, licensed servers, and off-duty Police Officers or private security.
- 5. Sponsor will post a \$1,000 damage deposit with the Parks Division prior to the event and acknowledges that this organization will be responsible for any and all actual field renovation costs that may result from this event.
- 6. Sponsor understands that the marketing and sale of all event related merchandise on municipal parkland must be pre-approved by the Parks Division, including the location and set-up of the vending sites. Further, if any food or beverages are sold or served at the park, sponsor or vendors will comply with all City Health Department regulations.
- 7. The event must conclude by 6:00 p.m., followed immediately by takedown and clean up.
- E. Letter of Intent dated February 6, 2007 from Wingra School, Inc. re: Dudgeon School Building
 - 1. The letter states the parameters and process for dividing the City-owned Dudgeon School block, which is not currently designated as parkland. The letter states that the school building and land in the middle of the block will be sold to Wingra School for renovation, expansion and continued use as a school and community building. The front and back portions of the block, containing open space and recreation facilities, will be dedicated as parkland (Dudgeon Park). The park will be improved, maintained, and operated by Wingra School for their playground activities and for public park use.
