

1. Before you engage in lobbying as a lobbyist, you or your principal must file an authorization with the City Clerk.
2. Your principal is not permitted to authorize you to lobby unless you are registered with the City Clerk.
3. If your principal spends or will owe more than \$1,000 for lobbying services in any reporting period (half year), the principal must file expense statements with the City Clerk for the remainder of the calendar year?

Dear Members of the Common Council,

I live very near this property, and like several of my neighbors, I'm not so sure I want to see a building go up there. I went to the Plan Commission meeting last week, to gather information for myself since the people who want to build it had scheduled no community meetings to discuss this project with us, the community who lives here. Not good process, in my opinion. They send a flyer around this winter, but that's all. Our alder at the time did nothing to inform his constituents or foster dialogue about the project. I'm also on the Board of Directors of Community GroundWorks, and reps from the Historical Society did not previously communicate with our organization about this project, which is right next to our work at Troy Gardens.

I spoke to the architect and whoever he was with after the meeting, and they told me the project would not tear down the forest in front of the property, where CGW, in partnership with the Central Wisconsin Center which owns the land, has created a forest education space complete with learning areas and a fort building area where kids can play. The men told me the new project would not impede our use of this forest, and the trails within would remain open to all as they are now. However, at this point all we have are words, no real agreements. I don't trust only words in the long run.

No community conversations have taken place to brainstorm what other use this land could have (like urban agriculture?), or alternative nearby locations where this building could be built. My neighbors and I have many questions--what is the timeline for expansion? Why does this 2-story building which is actually as tall as a 4-story building have to be so close to the street? The state owns many acres of land in this vicinity--why is this location best? Will there be written agreements in place guaranteeing Community GroundWorks' continued use of the forest? Perhaps the answers to these questions might persuade, but who knows? We have not had the opportunity to ask them.

If staring the conversation now delays their timeline, too bad. They should have had an open community process in the first place. I'm not sure I oppose this building--in my opinion, it's too tall and too close to the street but it could be worse. However, I do oppose the lack of community input. Process is everything. Sending around a nondescript flyer and getting on with one's plans does not suffice.

In short, it's the lack of community input and conversation bothers me most. That's not how we roll on the Northside of Madison.
