Fiscal Note

The annualized total cost for the reclassification of these positions is estimated at \$5,460, or \$7,693 including benefits. This amount will be included in the 2011 Requested Budget. Costs for the remainder of 2010 are projected at \$4,322, or \$6,090 including benefits. This amount will be covered by the management of salary savings. No additional appropriation is required.

Resolution deleting the classifications of "Assessment Aide 1" in Compensation Group 20, range 09 and "Assessment Aide 2" in Compensation Group 20, range 11, and creating the classifications of "Assessment Technician 1" in Compensation Group 16, range 08 and "Assessment Technician 2" in Compensation Group 16, range 10.
