# City of Madison Parks Long Range Planning Subcommittee Establish Ice Rink Service Area Standards Report Two April 20, 2017

# Background

Report One, presented to the Subcommittee at its February 28 meeting, reviewed the results of interviews with Adopt Ice Partnership (AIP) volunteers and Parks staff who manage the AIP program. That report also proposed next steps for developing a standards policy. This Report Two proposes a structure for an AIP standards policy.

# <u>Introduction</u>

The policy is intended to guide Parks staff in responding to requests for new AIP rinks in existing *neighborhood* parks and provides a procedure for ending an AIP site.

### **Goals of a Standards Policy**


The goals of this policy are to:

- 1. increase winter use of the park system;
- 2. be responsive to citizen-initiated requests for skating rinks;
- 3. promote equitable rink access, park system-wide;
- 4. manage expectations about amenities, e.g., boards, benches, warming hut, lights; and
- 5. acknowledge resource constraints

# **Key Factors Affecting Expected Success of AIP sites**

- 1. Coordinator availability
- 2. Sufficient volunteers removal of snow and "hosers"
- 3. Water point or water truck usage
- 4. Satisfactory site (size, drainage, )
- 5. Staff capacity to support rink
- 6. Demographics that suggest sufficient usage and demonstrated rink use
- 7. Location relative to other rinks

### ADOPT ICE PARTNERSHIP: APPLICATION PROCESS



- Can come in informal manner such as email or phone call (not an application)
- Is this a neighborhood park?
- -What is the proximity to other ice rinks?
- Site conducive to master plan?
- Is there a location adequate (flat, size, not damage other uses)
- -Different types of rink design appropriate for site. Ice liner solution? If so, size/cost?
- Water source or rely on water wagon?
- In which Operations section is it located (West, Central, East) and what are the staff resources available?
- -Staff will strive to complete review in 60 days


# **YES - RINK SOLO BY GROUP**

Rink may be established by group without Parks resources. Group takes sole responsibility for installation, maintenance & monitoring.


### **YES- RINK IN FUTURE**

# YES – RINK THROUGH PARKS

Rink may be established by Parks in partnership with community

- Identify a coordinator
- Demonstrate has enough volunteers to maintain the rink, especially hosing and snow clearing (a core group of six to twelve)
- Alder & NA support
- Meet with a current AIP coordinator
- Sign doc stipulating understanding of roles, monitoring/reporting and performance criteria
- Demonstrate resources to fund, if proceeding without Parks resources or cost sharing
- Parks Superintendent Approves & signs
- Location enters a two year probationary period
- Group must attend annual training re: best practices

# Criteria for Ending an Adopt Ice Location

Over time, there is the potential for a current Adopt Ice location to no longer be cared for adequately or used sufficiently. If Parks observes this trend, they will follow the below process:

- 1) Operations will document issues
- 2) Community Services Manager will contact Adopt Ice Partner within 10 days of Operations identified issues to request a meeting to discuss resolution and agree a time period to correct the issue.
- 3) If issue is severe, AIP may be ended for season and future years.
- 4) If issues are able to be corrected, Operations and Community Services will place rink in a one year probationary status.
- 4) If maintenance and/or usage issues have not been corrected following the probationary year, the location may be removed from the Adopt Ice Partnership program.
