The gift of \$ 500,000 benefits Lakeview Library's collection and funds a Teen Services Librarian for 3 years.

## 9. APPROVAL TO TRANSFER \$ 300,000 FROM FUND BALANCE TO OPERATING BUDGET

Donations received are posted to Income Statement Revenues. Any unspent funds must be moved from Income Statement Revenues to Balance Sheet Unearned Revenue. If they are not moved, the Revenue lapses to Fund Balance and is no longer available to be spent.

Madison Public Library Foundation received donations from Venture Fund for an Early Literacy Program of \$ 100,000 and from Schmidt Sciences for a Bubble Up program of \$ 200,000. These funds were paid to Madison Public Library at the end of 2017. These funds were not spent in 2017, and the required entry was not made; therefore they lapsed to Fund Balance.
