My name is Jamie Bislew and I have been a CVT for the last 10 years.

As someone who works every day with sick and injured dogs, I'm deeply concerned about the proposal to ban the sale of cats and dogs in Madison pet stores. I oppose this ordinance. In my experience, responsible pet stores are one of the strongest forces keeping breeders accountable. When ANIMART was open in Madison, we had clear standards for where dogs came from and took that role seriously. That accountability system matters now more than ever, especially with so many families turning to mixed breeds.

If ANIMART noticed a trend, such as puppies from a certain litter developing hip issues, we could report it back to the breeder and make sure it was addressed. If a breeder had sick dogs, ANIMART stopped sourcing from them until the issue was fixed and the dogs were properly quarantined. That kind of feedback loop doesn't exist with online sellers or rescues that sell through Facebook or Craigslist. Those sellers disappear once the money is made, and there's no way to trace where the dog came from or stop the problem from happening again. Another major concern is that pets listed online can fall into the wrong hands. Dogs given away or sold cheaply on the internet are sometimes used as bait in dog fighting. At our clinic, we take this seriously and run background checks through the Wisconsin Court System to make sure anyone adopting or rehoming an animal doesn't have a history of animal abuse.

This ordinance sends the wrong message about responsible pet stores like ANIMART. We were transparent, careful, and proactive. We held breeders to humane standards and even made sure breeding dogs got time off between litters. We also gave families honest guidance about which dogs fit their lifestyle, something no online seller or breeder with a few puppies to move will do. Pet stores like ANIMART should be seen as part of the solution, not the problem.

My name is Dr. Susan Krebsbach, and I have been a practicing veterinarian for over 30 years. I founded my own animal behavior practice here in Wisconsin, <u>Creature Counseling</u>, and I am honored to serve as the <u>Wisconsin Representative for the HumaneVMA</u>, a national organization dedicated to using their expertise and resources to advance animal welfare via leadership, advocacy, education and service. I am writing to express my strong support for Ordinance 90423, which prohibits the sale of dogs and cats in retail pet stores.

This ordinance is a critical step in protecting both animals and families in our community. Passing this legislation ensures that we will not become a target for the cruel and exploitative practices of puppy mills. Veterinarians know all too well the suffering these facilities cause: dogs confined to cramped wire cages, deprived of human interaction, bred repeatedly without regard for health or genetic soundness, and subjected to makeshift "medical care" by untrained individuals. These conditions amplify serious genetic disorders and create lifelong health and behavioral problems.

The consequences of these practices are evident in the exam rooms of veterinary clinics across the country. Puppies sold through pet stores—almost always sourced from high-volume breeding facilities—frequently arrive with acute and chronic illnesses, including:

- Intestinal parasites such as worms, giardia, and coccidia
- Contagious respiratory diseases like CIRDC and pneumonia
- Deadly viral infections such as parvovirus and distemper
- Chronic ear, eve, and skin infections
- Neurological disorders including seizures
- Orthopedic conditions such as hip dysplasia and spinal abnormalities
- Inherited heart, liver, and other organ diseases
- Blindness and deafness

Beyond the heartbreak these conditions cause families, some of these diseases pose zoonotic risks to humans. The CDC has repeatedly issued <u>outbreak advisories</u>, <u>notices of ongoing investigation</u>, and a <u>Morbidity and Mortality Weekly Report</u> linking pet store puppies to antibiotic-resistant Campylobacter infections. The <u>American Medical Association</u> has warned of the growing public health threat. Children, the elderly, and immunocompromised individuals are especially vulnerable.

In addition to medical concerns, veterinarians regularly see families struggling with behavioral challenges in dogs purchased from pet stores. Research published in the <u>Journal of Veterinary Behavior</u> confirms what we observe in practice: dogs from high-volume breeding facilities are significantly more likely to develop aggression and emotional problems compared to dogs from responsible sources.

By passing Ordinance 90423, Madison will join eight states and more than 520 localities nationwide in rejecting the sale of commercially bred dogs and cats in pet stores. This legislation will protect

animals from cruelty, safeguard families from financial and emotional hardship, and uphold the standards of humane veterinary care. Importantly, it will not limit opportunities for residents to welcome pets into their homes—adoptions from shelters and rescues, as well as purchases from responsible breeders, remain fully available.

I urge you to adopt this ordinance and affirm Madison's commitment to animal welfare, public health, and responsible pet ownership.

This resolution seems unnecessarily complicated. Alders will be required to file a report of the amount and date of contributions and contributors for all donations with the City Clerk within six months of the receipt of the donation. (This is the requirement under MGO 3.35(5)(a)2.d, though the resolution states "within 6 months after the completion of the fundraising.")

When the Mayor and Alders were authorized to encourage donations to the Abundant Life Christian School Emergency Fund (Legistar 86528), no Alder reporting was required. The resolution stated: "donations to the Abundant Life Christian School Emergency Fund will be made directly to Abundant Life Christian School via United Way of Dane County and therefore there will be no report regarding the donations as required to be submitted to the City Clerk under MGO 3.35(5)(a)2.d."

Similarly, Shelter Friends of Dane County has two 501(c)3 organizations to accept donations on its behalf until it obtains 501(c)3 status. From Shelter's website:

"Two Ways to Give

As Shelter Friends of Dane County awaits approval to be a 501(c)3 organization, we are grateful to United Way of Dane County and Madison Community Foundation for accepting donations on our behalf."

Alders could encourage donations through these organizations and thus avoid the need to track and report contributions.

There would be additional benefits. The resolution states "that members of the Common Council shall take care to not express or imply that any fundraising requests are in any way connected to other business or proposals ..." Yet a donor giving an Alder \$100K could certainly create a sense of warm feelings toward that donor — a risk that would not exist if contributions are given to the charity. Plus, there would be no ability to track which Alders are better fundraisers.

Staff told the Board of Health Madison and Dane County that "we have largely not been involved in the creation of this ordinance." (Minute 22 of 11/5/2025 meeting.)

This lack of staff involvement is readily apparent from little things (the section cited in proposed 23.65(2)(a) does not identify the section as a Wisconsin Statute) to big things.

- The vast majority of ordinances banning pet sales require an "animal rescue organization" to have 501(c)(3) tax-exempt status in order to prevent breeders from circumventing the law by setting up a nonprofit corporation. The proposed ordinance merely requires the "animal rescue organization" to be a not for profit organization.
- 2. Many prohibitions in other municipalities/states include rabbits in addition to cats and dogs. (Cambridge, MA includes arachnids, birds, mammals, amphibians, and reptiles.)
- 3. While a Wisconsin State Journal article reported Alder Evers as saying there are not any pet stores currently selling dogs or cats, that is not entirely accurate. There is a store that sells kittens/cats, kittens/cats that freely roam the store. This store has been taking in unwanted kittens for many years. Will this store be grandfathered or will their sales be banned as of the ordinance's effective date?
- 4. The definition of "animal shelter" tracks Wisconsin law. There does not seem to be a need to separate out "animal shelters." Dane county shelters that are licensed under Wisconsin law are either an "animal control facility" or an "animal rescue organization." (There is one exception, the Madison College vet tech program, which directly adopts out animals used in the program.)
- 5. The definition of "animal shelter" uses other terms ("humane society", "animal welfare society", "animal rescue group", "other nonprofit group") which are not defined. Perhaps a humane society is the same thing as an animal control facility and perhaps an animal rescue group is the same thing as an animal rescue organization, but terms need to have clarity. The "other nonprofit group" could even be an organization that obtains animals from a breeder or broker for compensation or profit since there is no prohibition (unlike an "animal rescue organization").

On Friday we reached out to Alder Evers directly, and I'm hopeful we can speak soon. In the meantime, I would value the chance to speak with other members of the Council as well.

While I respect the intentions behind this proposal, it is based on assumptions that don't align with the reality of how responsible pet stores operate.

# In my store:

- We regularly steered families away from pets that were not the right fit for their home, time, or activity levels.
- Many of those families would have otherwise turned to online marketplaces to find a specific breed, where unethical breeders and scams are widespread.
- We carefully selected our sourcing, prioritized regulated breeders, and maintained transparency at every step.
- When a family needed help after bringing a pet home, they returned to us. That
  accountability disappears in online sales, where sellers often delete profiles and cut off
  contact.

To be clear, this ordinance would not change operations for any businesses that currently exist. But it sends the wrong signal, misrepresents the role of responsible pet retailers, and discredits those of us who worked hard to create safer, more accountable pathways for families bringing pets home.

These sellers operate outside the law, leaving families vulnerable to scams and sick puppies with no accountability once money changes hands.

Open intake local shelters perform difficult and important work, but we are deeply concerned by the growing number of "rescues" and dealers that operate unethically. Some purchase dogs at auctions from substandard breeders, then transport them across state lines. Many of these puppies arrive sick with conditions like giardia, which can spread quickly and put local dogs at risk. The proposed Ordinance would limit options for families seeking a puppy or kitten — forcing them to purchase from unscrupulous sellers.

Even more puzzling, Madison doesn't currently have a single pet store that sells dogs or cats. In fact, it is a miss-perception that pet stores sell puppies from puppy mills. Advocates claim the ban would crack down on "puppy mills" and steer consumers toward shelter pets, but evidence shows these policies do neither. This ordinance is not actually designed to fix the real problem. It's part of a national campaign led by a Washington, D.C. based lobbying group pushing pet-sale bans from coast to coast. They've made a business out of convincing local officials to pass measures that look good on paper but do nothing to stop bad breeders.

Laws are already in place which regulate the dog breeder and seller industry, designed to protect

the welfare of dogs and to protect the consumers who buy or adopt them:

Wisconsin Act 90 of 2009, requires breeders and others involved in sales or adoptions to be licensed and inspected, ensures dogs are examined by a veterinarian before placement, and prohibits the sale of puppies younger than 7 weeks old. Banning pet sales at Madison shops is bad idea | Dr. Jim and Ruth Metz

Madison's proposed ban on dog and cat sales may sound compassionate — but in reality, it would hurt the very animals it aims to protect.

As Wisconsin pet store owners with a veterinary practice, we have dedicated our careers to improving the health and welfare of animals while promoting their bond with humans for more than 40 years. We've seen firsthand how strong standards, responsible breeding and trusted local stores lead to the best possible outcomes for pets and their families.

That's why we're deeply concerned about Madison's proposal to ban the sale of dogs and cats in local pet stores. Ald. Tag Evers, who introduced the measure, has refused to consider changes to its language — and in doing so, he's ignoring the harm this would cause to animals and the community.

For instance, the ban would limit options for families looking for specific breeds or health-tested animals — pushing them toward purchasing from unscrupulous sellers. More puzzling, Madison doesn't have a single pet store that sells dogs or cats.

Advocates claim the ban would crack down on "puppy mills" and steer consumers toward shelter pets. But these policies do neither.

This proposal is part of a national campaign led by a Washington, D.C.-based lobbying group pushing pet-sale bans from coast to coast. They're trying to convince local officials to pass measures that look good on paper but do nothing to stop bad breeders.

When we opened our first Animart Pet Store in Beaver Dam in 1983, we built it on community

trust. From the beginning, families have known they can come to us for guidance on finding the right pet to fit their lifestyle — and to bring home a healthy, well-cared-for companion.

A responsible local pet store supports the understanding of animals. It is a trusted place for questions, which is hard to find online.

Over time, the industry has evolved for the better. Breeders are more professional. Inspections are more rigorous, and consumer expectations are higher than ever. The few remaining stores in Wisconsin that sell puppies operate under some of the tightest standards anywhere.

If families can't turn to responsible pet stores, they're pushed into an unregulated marketplace where it's nearly impossible to know what they're getting.

The human-animal bond teaches kids responsibility, empathy and the cycle of caring for another living being. Weakening the avenues that connect families with healthy pets hurts that bond — and ultimately, the animals themselves.

Instead of another symbolic ban, Madison needs commonsense solutions that protect animals and preserve the right of families to bring home a trusted companion. Let's build on what works instead of dismantling it.

re: ORDINANCE 90423

I ask you to ask yourself, "What is the purpose of this Ordinance?"

Is the problem pet stores? There are no pet stores in Madison even selling puppies – so just WHAT is the Problem?

Is the problem Puppy Mills? We ALL want to eliminate Puppy Mills – and the USDA and WI DATCP are already doing an excellent job of eliminating and preventing them.

In the past, there were unscrupulous pet stores which did source puppies from puppy dealers and high-volume commercial breeders - puppy mill breeders - leading to puppies with poor health and behavioral issues due to inadequate care and socialization.

Many pet stores have transitioned to a model where they partner with local animal shelters and rescues, hosting adoption events. We all support shelters and all they do for unwanted pets. However, many individuals and families still want a young puppy or kitten and are not interested in adopting an older dog or cat with potential health or behavioral problems.

So, where can they go for a puppy?

Maybe the local Humane Society has some puppies.

And, Why SHOULDN'T they go to the LOCAL PET STORE? - Which is also licensed and inspected by DATCP, following all facility, care and sale requirements?

Following today's Pet Industry Best Practices, a Pet Store SHOULD Adopt Out (or "sell") Puppies & Kittens -- & Bunnies, Fish, Birds, Reptiles & Pocket Pets.

Reputable HUMANE Pet Stores offer: (and I will focus here mostly on dogs & cats)

Professional, knowledgeable staff with close veterinary oversight.

- Health Documentation including a veterinary exam & health certificate, needed vaccinations, spay or neuter already performed or, for larger breeds, included in the price to be done later at the ideal age for that breed - Healthy pets that won't add to an overpopulation problem.
- Selection of only animals & breeds that make good pets
- Screening of potential owners to ensure they are a good match for the specific pet and are able to provide a suitable, loving, and stable life-long home.
- Transparency and Sourcing: The store should gladly provide information on where every dog is sourced. Reputable sources are responsible breeders or rescue organizations, not puppy mills.
- Well socialized animals with both people & other dogs. Many Pet Stores today are offering puppy parties & training classes to prevent the behavioral problems which lead to surrendering the pet to a shelter
- Education and Support: Store staff should be knowledgeable about the specific breed's needs and serve as an ongoing resource for new owners, helping them with training and care questions.
- Comprehensive Contract with a Health guarantee & return policy, preventing the pet from ending up in a shelter.

While our business, Animart, accepts unwanted litters of puppies & kittens and deals primarily with smaller local breeders, all larger breeders must be DATCP licensed PLUS follow our own Animart Breeder Excellence Standards which go beyond the USDA and state regulations. We require:

- o At least one non-breeding heat cycle after each litter.
- o Puppies and kittens must be 8 weeks old vs 7.
- o Quality AFCO labeled food (vs "appropriate" food).
- o Frequent positive human contact is needed to ensure a well socialized pet.
- o The breeder must provide a health guarantee to help hold them accountable to breed healthy animals.
- o We don't work with breeders who sell animals to research facilities.
- o Breeders must allow random visits from an Animart employee on their property at least once per year.

Unintended consequences of passing this "feel-good" ordinance:

• Limited access to breeds and choice – leading to emotional impulse purchases based on a breed's look vs that breed's general personality, care & needs which may not be the ideal

fit to that person or family's lifestyle, expectations and financial abilities – leading to more abandoned or surrendered pets in shelters.

- Inadvertently supports black-market breeders and dealers as people rely more on the internet, shopper guides, farmer's markets, fairs, etc, to find a puppy without the direct oversight of DATCP regulations and consumer protections. It can be difficult for consumers to know the actual origin and conditions in which the dogs were kept, the health status and vaccination history, potentially leading to a higher likelihood of behavioral and genetic health issues and more abandoned or surrendered pets in shelters.
- Supports radical animal rights groups whose ultimate goal is to eliminate ANY animals to be kept as pets no dogs, cats, fish, reptiles, birds or pocket pets
- If there are fewer pets owned, there will be no future for many local small businesses no need for companion animal veterinarians, groomers, boarding facilities, doggie day care, trainers or pet stores along with all the larger pet industry manufacturers and allied businesses.

We all recognize the beneficial value of the human-animal bond that provides significant emotional, psychological, and physical benefits to both humans and animals. The human-animal bond benefits children and seniors through improved physical and mental health, and emotional support. For kids, pets can help with social skills, reading, and empathy, while for seniors, pets can reduce loneliness, slow cognitive decline, and encourage physical activity. The bond provides unconditional companionship, which can help buffer stress for both age groups and foster resilience.

We all agree that bad breeders need to be shut down, but this misguided ordinance will not do that. In reality, the bad breeders this legislation targets will go untouched while responsible pet stores pay the price and consumers and pets are less protected from the unreputable breeders. Reputable HUMANE Pet Stores are NOT the Problem - but can be part of the Solution.

I ask you to NOT take a step backwards, but to take a step FORWARD.

Vote NO to the Madison Ordinance 90423.

Banning pet sales at Madison shops is bad idea | Dr. Jim and Ruth Metz

Madison's proposed ban on dog and cat sales may sound compassionate — but in reality, it would hurt the very animals it aims to protect.

As Wisconsin pet store owners with a veterinary practice, we have dedicated our careers to improving the health and welfare of animals while promoting their bond with humans for more than 40 years. We've seen firsthand how strong standards, responsible breeding and trusted local stores lead to the best possible outcomes for pets and their families.

That's why we're deeply concerned about Madison's proposal to ban the sale of dogs and cats in local pet stores. Ald. Tag Evers, who introduced the measure, has refused to consider changes to its language — and in doing so, he's ignoring the harm this would cause to animals and the community.

For instance, the ban would limit options for families looking for specific breeds or health-tested animals — pushing them toward purchasing from unscrupulous sellers. More puzzling, Madison doesn't have a single pet store that sells dogs or cats.

Advocates claim the ban would crack down on "puppy mills" and steer consumers toward shelter pets. But these policies do neither.

This proposal is part of a national campaign led by a Washington, D.C.-based lobbying group pushing pet-sale bans from coast to coast. They're trying to convince local officials to pass measures that look good on paper but do nothing to stop bad breeders.

When we opened our first Animart Pet Store in Beaver Dam in 1983, we built it on community trust. From the beginning, families have known they can come to us for guidance on finding the right pet to fit their lifestyle — and to bring home a healthy, well-cared-for companion.

A responsible local pet store supports the understanding of animals. It is a trusted place for

questions, which is hard to find online.

In today's market, placing healthy, responsibly raised pets with families is one of the few revenue streams to help small, family-run businesses stay afloat. Without it, competing with online giants such as Amazon and Chewy becomes nearly impossible — a pressure we felt firsthand when it forced us to close our Madison location.

With our veterinary practice, we provide medical oversight and work closely with dog breeders to ensure only puppies from unwanted litters and from inspected, state-compliant facilities ever make it to our stores.

If a breeder fails to meet our standards — by overbreeding, neglecting cleanliness or ignoring health protocols — we refuse to purchase from them again.

Over time, the industry has evolved for the better. Breeders are more professional. Inspections are more rigorous, and consumer expectations are higher than ever. The few remaining stores in Wisconsin that sell puppies operate under some of the tightest standards anywhere.

If families can't turn to responsible pet stores, they're pushed into an unregulated marketplace where it's nearly impossible to know what they're getting.

In states such as California and New York, similar "pet prohibition" laws have fueled black markets for puppies. Just last month, dogs were being sold out of car trunks in New York City.

And ordinances such as Madison's pass, families turn to Craigslist and Facebook Marketplace — places where no one checks breeding conditions, vaccination records or genetic health. It creates the perfect environment for puppy mills and scammers to flourish, exacerbating the very problem the ordinance claims to solve.

We understand the good intentions behind this proposal. Everyone wants to protect animals. But you can't legislate compassion with bad policies.

If Madison truly wants to improve animal welfare, it should work with licensed veterinarians, breeders and pet store owners who are already setting the bar for care. Madison could strengthen existing transparency requirements or even require stores to have veterinary oversight.

The human-animal bond teaches kids responsibility, empathy and the cycle of caring for another living being. Weakening the avenues that connect families with healthy pets hurts that bond — and ultimately, the animals themselves.

Instead of another symbolic ban, Madison needs commonsense solutions that protect animals and preserve the right of families to bring home a trusted companion. Let's build on what works instead of dismantling it.

Dear Members of the Madison Common Council,

As a Wisconsin veterinarian for over 40 years, I am contacting you regarding the proposed Madison Ordinance 90423 which would prohibit the sale of cats or dogs in retail pet stores.

At our veterinary clinics and pet stores, my wife Ruth and I have dedicated our careers to improving the health and welfare of animals and promoting the human-animal bond. We've seen firsthand how strong standards, responsible breeding, and trusted local stores lead to the best possible outcomes for pets and their families.

That's why we're deeply concerned about Ordinance 90423. Alder Tag Evers, who introduced the measure, has not responded to our requests to discuss our concerns. In doing so, he's ignoring the very real harm this ordinance would cause to both animals and the community.

We share the Council's commitment to protecting animal welfare, but this proposal sends the wrong message and risks doing more harm than good. Instead of promoting accountability, it encourages a system that opens the door to unregulated online sellers and individuals who sell dogs out of parking lots and on the internet. These sellers operate outside the law, leaving families vulnerable to scams and sick puppies with no accountability once money changes hands.

Open intake local shelters perform difficult and important work, but we are deeply concerned by the growing number of "rescues" and dealers that operate unethically. Some purchase dogs at auctions from substandard breeders, then transport them across state lines. Many of these puppies arrive sick with conditions like giardia, which can spread quickly and put local dogs at risk. The proposed Ordinance would limit options for families seeking a puppy or kitten — forcing them to purchase from unscrupulous sellers.

Even more puzzling, Madison doesn't currently have a single pet store that sells dogs or cats. In fact, it is a miss-perception that pet stores sell puppies from puppy mills. Advocates claim the ban would crack down on "puppy mills" and steer consumers toward shelter pets, but evidence shows these policies do neither. This ordinance is not actually designed to fix the real problem. It's part of a national campaign led by a Washington, D.C. based lobbying group pushing pet-sale

bans from coast to coast. They've made a business out of convincing local officials to pass measures that look good on paper but do nothing to stop bad breeders.

Laws are already in place which regulate the dog breeder and seller industry, designed to protect the welfare of dogs and to protect the consumers who buy or adopt them:

Wisconsin Act 90 of 2009, requires breeders and others involved in sales or adoptions to be licensed and inspected, ensures dogs are examined by a veterinarian before placement, and prohibits the sale of puppies younger than 7 weeks old. The law took effect on June 1, 2011, and it remains to be a strong state framework for protecting animal welfare.

ATCP 16 is the Wisconsin Administrative Code chapter that regulates dog sellers and facility operators, establishing licensing and minimum care standards for dogs.

Dog breeders in Wisconsin are subject to licensing and inspection by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP), regulating and preventing "puppy mills" from existing in Wisconsin.

The USDA works to ensure the humane treatment of more than 1 million vulnerable animals nationwide. Through inspections and outreach, they oversee thousands of groups, from breeders to managers of horse shows, to make sure their animals receive care and treatment that meets Federal standards.

Dear Council Members,

I've been contacted about the ordinance you will be voting on next Tuesday that would prevent the sale of dogs and cats in pet stores versus a potential alternative ordinance that merely regulates where any future stores could source puppies from. Below are some important points to consider.

First, other cities and states that merely regulate sourcing still have major problems with puppy stores. Sourcing regulations have not stopped stores from buying from cruel puppy mills and certainly haven't stopped deceptive sales tactics, sick puppy sales or predatory lending. Las Vegas tried sourcing regulations for years, and earlier this month the Las Vegas City Council voted to phase out the sale of puppies altogether in their 13 puppy stores because the regulations weren't working. Illinois started with regulations and then passed their statewide ban on the retail sale of puppies. The same goes for New York State and Maryland, and many municipalities.

Second, responsible breeders do not sell to pet stores or other third-party sellers. They would never hand a litter of puppies to a truck driver and hope for the best. Instead, they screen potential buyers, invite them into their homes to see how their dogs are raised, and provide full transparency on genetic testing, veterinary records, and breed-specific issues. Responsible breeders remain lifelong resources for those who buy their puppies and always take a dog back if a family can no longer care for her. This standard is widely recognized: the American Kennel Club offers the same <u>guidance</u>, and most breed clubs forbid their members from selling puppies to pet shops. For instance, the breed club representing the most popular breed in the nation requires breeders to agree to the following: "I will not sell a French Bulldog to any non-standard breeder, puppy broker, pet store, puppy mill, litter lot sales or any other commercial enterprise whose business is involved in like activities" (<u>French Bull Dog Club of America</u>).

Third, it is not feasible to require pet stores to only buy puppies from "ethical" sources because there is no reliable oversight of dog breeders ensuring humane conditions. USDA oversight of commercial breeders still permits inhumane practices, including housing dogs in stacked wire cages only six inches larger than their bodies, and enforcement of even these minimal standards is poor. Some states regulate commercial breeders who sell to pet shops, but no state has standards that most Americans would consider acceptable conditions for dogs to be subjected to for their entire lives. And each state has their own enforcement challenges. There are some voluntary certification programs, but these represent a sliver of the industry and aren't reliably enforced either. The only way for a consumer to know they are buying a puppy from a humane source is to visit the breeder in person and avoid third party sellers.

Madison is poised to become the **15<sup>th</sup>** locality in Wisconsin to enact a humane pet shop ordinance, and the **521<sup>st</sup>** in the nation. Many of these local lawmakers wrestled with this same question, wondering if there was another away to crack down on the puppy mill-to-pet shop pipeline that is so problematic for animals and consumers. Some learned the hard way by enacting regulations first. Others saw that selling weeks-old puppies like mere products in retail stores is simply unfixable, and the pipeline behind it is too broken to merely regulate.

This is the time for Madison to enact the humane pet shop ordinance. No businesses are impacted, yet it's a crucial step in preventing bad actors from moving into town. Madison will remain open to the vast majority of pet stores that firmly refuse to sell puppies and residents will continue to find the pet of their choice from our region's impressive network of shelters, rescues and responsible breeders.

Humane World for Animals, Bailing Out Benji, Best Friends Animal Society, along with eight Madisonarea animal welfare organizations and five local pet-related businesses, are writing to express our strong support for a humane pet store ordinance in Madison, detailed in the attached letter. This ordinance will prohibit the sale of commercially raised puppies and kittens in pet stores, limit the flow of sick and inhumanely bred puppy mill dogs into the community, and protect our friends and neighbors from unknowingly supporting such a cruel industry.

Eight states and over 500 localities, including Whitewater, Appleton, Fort Atkinson, Beloit, Wauwatosa, Waukesha, La Crosse, Sun Prairie, Wausau, Delavan, the Village and City of Pewaukee, West Allis, and Marshfield have already similar ordinances for good reason:

- Puppy Mills: Public records show that the majority of pet shop puppies come from large-scale, inhumane commercial breeders and brokers with terrible animal welfare records. This is true for many pet stores in Wisconsin, including a notorious puppy retailer with stores in Janesville and Racine. Dogs in puppy mills are born into cruel and unsanitary conditions, taken from their mothers at just 7-8 weeks old, crammed into cages and trucked across the country near other stressed and sick puppies, where they are placed in pet shop cages like products.
- Consumer Protection: The puppy mill-to-pet shop pipeline produces puppies who are often sick, unsocialized, or have congenital defects, yet pet stores use misleading sales tactics to convince consumers they are buying the opposite. After paying thousands of dollars for a puppy, and sometimes financing the purchase with undisclosed interest rates as high as 188%, new owners often have steep veterinary costs and sometimes suffer the heartbreak of their new pet dying.
- <u>Public Health</u>: According to the <u>American Medical Association</u> and the CDC, pet shop puppies
  expose staff and customers to an antibiotic-resistant strain of *Campylobacter*—a result of pet
  shops' reckless overuse of antibiotics.

No pet shop needs to sell puppies. The massive retail pet industry - \$152 billion and counting – is dominated by the sale of pet products and services. Furthermore, this ordinance will not prevent consumers from obtaining the dog of their choice through reputable sources like local shelters, rescues, and responsible breeders who treat their dogs like pets and only sell directly to the public.

We urge Madison to join the other 14 communities across Wisconsin and take a stand against the nightmarish puppy mill-to-pet shop pipeline by passing a humane pet shop ordinance.

Many puppy-selling pet stores rely on deceptive lending schemes—high-interest financing plans that mislead families into taking on huge debts for puppies that are often sick or poorly bred. These practices harm consumers and have no place in our city.

Hello,

I live in the Birchwood Point South neighborhood on the far, far west side. I realize it is very late in the process and I am not sure if/how the amendment process works when an item reaches the full council, but I just learned about this proposal today.

I wholeheartedly agree with the proposal to ban selling cats and dogs through pet stores. I would like to see the list of animals expanded to other animals, including but not limited to guinea pigs.

I have had guinea pigs as pets for over ten years, so my concern is mostly focused on them, but the issues I describe also apply to other animals. They are not miniature starter pets they are often portrayed as. They have attitudes and individuality every bit as large as cats and dogs.

Guinea pigs and other small mammals sold in pet stores are often obtained from animal mills as abhorrent as the worst puppy mills. While these mills are purportedly regulated by the federal Animal Welfare Act, there is in fact little action taken against egregious offenders. Banning the sale of guinea pigs and other small mammals in pet stores is a small step we can easily take to discourage these mills.

Furthermore, pet stores often encourage or allow buying individual guinea pigs, when they are social animals that should not live alone. Cages sold by pet stores are, at best, the bare minimum size for one guinea pig. Supplies and treats often include ingredients that are deleterious for their health. In short, pet stores that sell guinea pigs do not set up the animals or their owners for success.

New York City, Boston, and Washington, DC are three large cities that ban the sale of guinea pigs in pet stores. I would like to see Madison added to the list.

Dear Alderpersons,

As a concerned citizen of the city of Madison, I urge you to consider the humane treatment and betterment of the animals who suffer daily in Wisconsin's puppy mills in your upcoming vote.

I have a personal connection to the issue: two summers ago, my adult sons were out camping when they stumbled upon a person dumping a mixed toy poodle off to the side of a desolate road, just north of Dane County, and less than a mile from two puppy mills. These puppy mills were very well-known to local authorities, as well as to animal welfare advocates who had raided one of them and had found numerous deceased animals that had died from the extreme summer heat.

My sons were able to coax this little white, starving dog into their car and bring him home. He was covered in fleas, missing large patches of hair, with incredibly inflamed skin, and looked terrified. We did everything we could to comfort him.

We named our new little boy Teddy, and I have done everything I can to get him back to good health. He, in turn, has given us love and joy. Unfortunately, my sons had also noticed another dog being dumped in the same area and at the same time as Teddy, but they were unable to capture it. The whereabouts of that little soul are unknown.

At Teddy's first vet appointment, we were told he was a "breeder dog". He also had no chip. I've since come to discover that the older "breeder dogs", once found to have a "defect": ie, an underbite, a bent foot, a wonky eye, etc., are usually either shot, drowned, or, as in Teddy's case, dumped.






