Projections for the year have event revenue coming in at 4% over budget and overall up at 2.84% over budget.

Entertainment events like Chosen Few Fighting Championships, and Q106 Storytellers have made an excellent comeback, though budgeted for revenues of \$20,000 the actual revenue produced is \$89,000.

Though meetings have not rebounded in numbers, the revenue produced by the meeting held this year is only 12% under budget. On a brighter note conventions have produced revenues 14% over budget this year. 2022 should end the year having held 488 total events of a budgeted 547.

6. 74637 Finance Report: Jeff Boyd, Business Manager

October was a busy month with five conferences and four entertainment events. Event revenue came in at \$523,000. Expenses were over budget in payroll and purchased services; however, the month still ended with a surplus of \$6,000. This year event spending averages have risen from \$7,000 to \$9,000 per event. Year to date the budget is at a \$299,000 surplus.
