#### VIII. NEW BUSINESS ITEMS

A. Madison General Ordinance Section 23.35- ID #05367 - City - ACTION Item

Schneider explained this is an administrative change to the ordinance to solidify cases when people are lawfully engaged in activity and a bite occurs.

Repealing and recreating Section 23.35 of the Madison General Ordinances to clarify that a violation occurs when an individual (not an animal) is engaged in a lawful activity.

Sponsors: Judy K. Olson

A motion was made by Sonzogni, seconded by Oakley, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER. The motion passed by acclamation.

B. Amend Chapter 47 of Dane County Code of Ordinances - Animal Control - County - ACTION Item

Wells began by thanking Tommye Schneider and department staff for reaching a reasonable resolution to a difficult situation. This is a good example of how the merged entity is helping the city and county. A key event for the Humane Society was caring for a large number of pit bulls for so many months. The Humane Society decided to restructure their contract with Dane County so this could not occur again to include limiting the care and types of animal cared for. In December, the Humane Society decided they would no longer continue to employ Humane Officers. The best option for public health and safety seemed to be to merge the service with the City Animal Control team. Items b. and c. on the agenda both have the same intent to transfer this service to the City County Health Department as of March 1.

The recommended action is to hire the current, two full time staff working for the Humane Society as officers of the department to work with the existing Animal Control Officers. They would be hired without interviews, as permanent County employees, with a six-month probation period, above minimum starting pay, and would not receive seniority credit for time worked at the Humane Society. There is also Limited Term Employee hours available for additional help, which will be monitored closely this year to assess the need for an additional position next year.

The budget implications are high, costing the county \$200,000 over what was budgeted in 2007. Vans and equipment need to be purchased for staff, and there is an increase in the cost per day to house animals at the Humane Society. Over the next year, there will

be additional resolutions and/or ordinances coming to the Board for their action related to this issue.

ACTION - Sonzogni/Kostelic moved to recommend approval both items, the ordinance (amending Chapter 47 and Resolution 249), passed unanimously.
