Lasky reviewed the next steps from the last meeting including the gathering of

data and research for this meeting. Committee members received a packet of information with data, maps and research items. Monica Host discussed that the 2010 census was used to gather some of the data used. There are approximately 13,500 children under 4 years old in the area. 7,177 are enrolled in child care or family child care through the City program. 4K attendance is about 1,080.

Madison has a strong system of child care in place with access and affordability still being issues. Transportation provided another hurdle for families as well as location of employment, schools and clinics in relationship to the neighborhoods where families live.

2. 35725 Child Care Forum Planning

The ECCEC usually plans a child care forum for this time of year. The committee decided to not hold a forum at this time due to the universal child care system discussion.

3. 35726 Accreditation Program Updates

Red Caboose still has its license and has addressed licensing issues. They remain at a 2 start level until after Jan 1 2015 when the state will consider their accreditation status. The center is still looking to relocate.

One City (previously Child Development Inc.) planned on opening in October, but now plans to open in January once 501C3 is received. There is a plan for One City to purchase the building from CDI for the cost of the debt including back taxes and loans that CDI owes.

4. 35727 CDD Updates

Host discussed the operating budget released by the Mayor. CDD received \$400,000 in supplemental funds. This will go towards a housing position and other initiatives. No additional funds were allocated towards child care. An additional \$75,000 was designated for the Emerging Opportunity Programs (EOP).

Forward Community Investments funding study is progressing. Weekly staff step discussions continue to occur. There has been good input from committees, agencies and staff for FCI to consider.
