Dear Board Members (who have listed email addresses):

This note concerns the subject agenda item at your meeting this evening.

For over 27 years, I have lived at █████ S Ingersoll St in Madison, four blocks south of McPike Park.

I fully support Mr. Robert Queen's proposal, that is the subject of the subject agenda item, and ask that you approve the proposal without change.

This proposal concerns the McPike Park Sessions event on June 3 this year. This event will be a wonderful musical and comedy event for Madison, the Marquette Neighborhood, and McPike Park. Your failure to approve Mr. Queen's eminently reasonable proposal will seriously damage the attractiveness of the event as a whole and its comedy part for the Madison and Marquette Neighborhood communities. Your failure to approve the proposal would be woefully disrespectful of the performers at and the people who look forward to attending that part of the event. Finally, Mr. Queen's proposal, which relates to sound amplification inside a sided tent, will not significantly increase after 8 PM noise outside the Park due to the event.
