

We, the residents of the Marquette Neighborhood, petition the city to reinstate the bus stop at the corner of Rutledge and Thornton Streets. Removal of the two stops on either side of the Yahara River have resulted in a four block distance (five if the bridge is included) without a bus stop. As a result this portion of the neighborhood is inadequately served even though there are number of multi-dwelling buildings and a higher population density close to the stop at Thornton.
