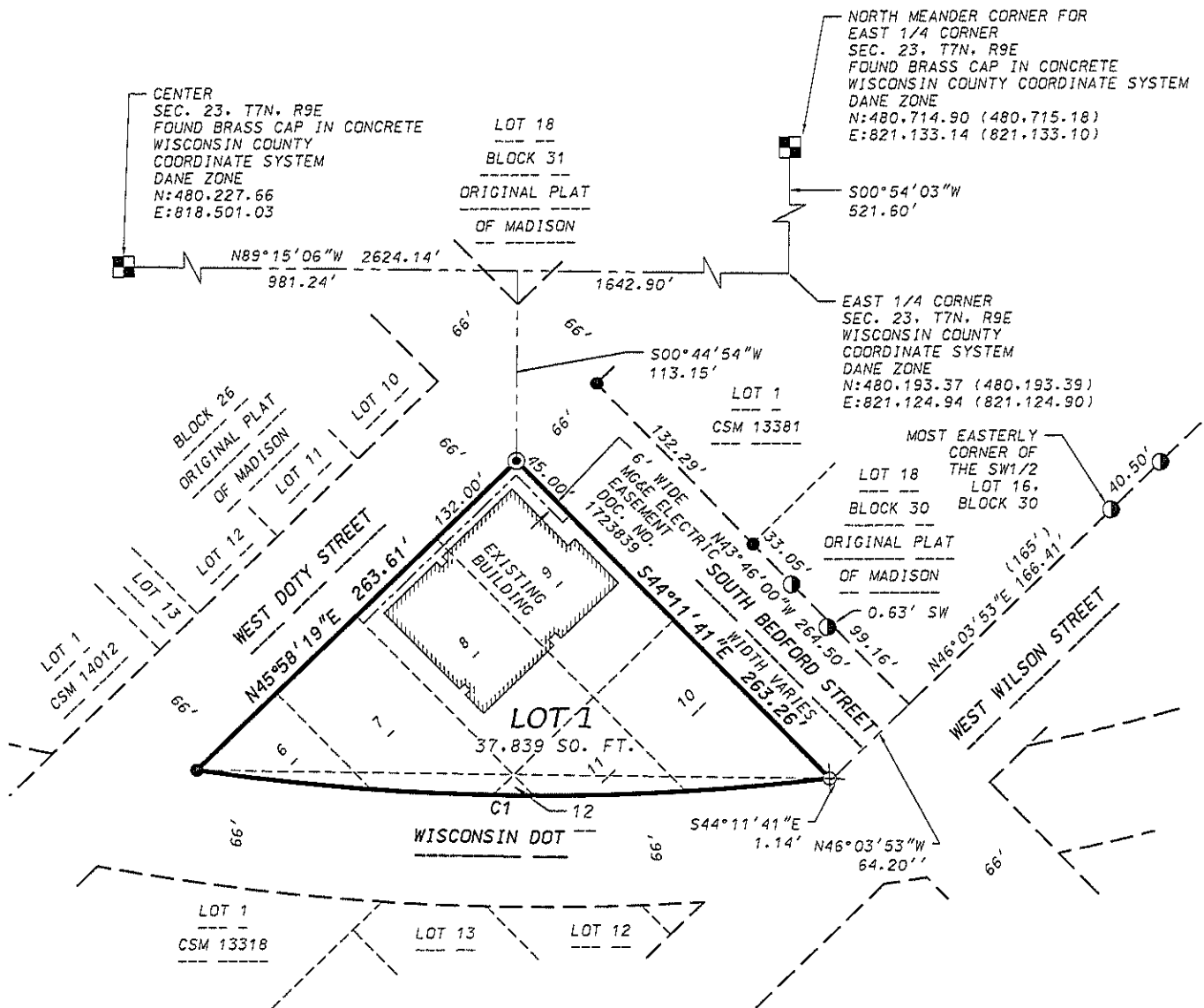


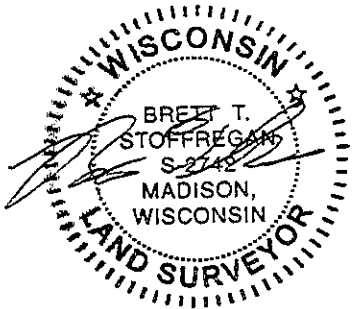

CITY OF MADISON, DANE COUNTY, WISCONSIN

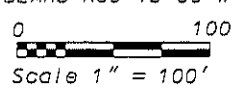

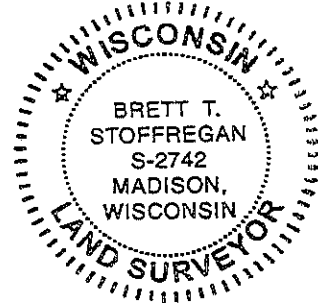

I have surveyed, divided and mapped the land described herein and that said map is a correctly dimensioned representation of the exterior boundaries and division of the land surveyed. Said land is described as follows:

Lot 8, Lot 9 and part of Lots 6, 7, 10, 11 and 12, Block 27, Original Plat of Madison, recorded in Volume A of Plats, Page 1, Dane County Registry, all located in the NW1/4 of the SE1/4 of Section 23, T7N, R9E, City of Madison, Dane County, Wisconsin, to-wit: Commencing at the East 1/4 Corner of Section 23 which lies $S00^{\circ}54'03''W$, 521.60 feet from the North Meander Corner of said East 1/4 corner; thence $N89^{\circ}15'06''W$ along the North line of said SE1/4, 1642.90 feet; thence $S00^{\circ}44'54''W$, 113.15 feet to the North corner of said Block 27, also being the point of beginning; thence $S44^{\circ}11'41''E$, 263.27 feet along the Northeast line of said Block 27 to a point on the Northerly line of a Wisconsin Department of Transportation right-of-way, also being a point of curve; thence Westerly along a curve to the right which has a radius of 1386.39 feet and a chord which bears $N89^{\circ}08'55''W$, 373.10 feet to a point on the Northwest line of said Block 27; thence $N45^{\circ}58'19''E$, 263.61 feet along said Northwest line to the point of beginning. Containing 37,839 square feet (0.869 acres).

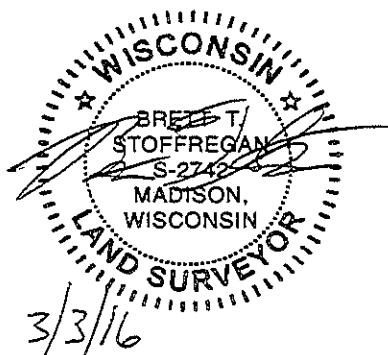

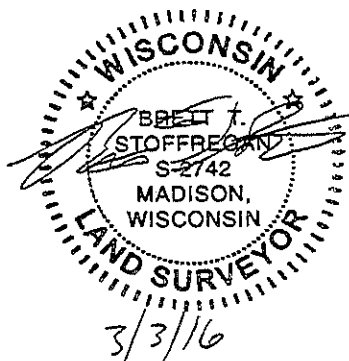
