Regarding the Dog Status Request for Veterans' Memorial Park, consider my household wildly **in favor.**

Our neighborhood has numerous respectful dog owners, and while often times it only takes one negative incident to ruin it for everyone--there is so much unused space in Veterans' Memorial Park that it makes no sense for it to be off-limits to dogs.

I'd even go so far as to request that the entire open area be fenced in and created as a dog run, where owners/dogs could play fetch, etc.

In a world that this green space was actively used for sports or literally anything else then I could understand being against this, but as a frequenter of this park, the only ones that use it is young teens at the basketball courts a few times a week during the summer, and then families will use the playground about 2-3 times a week in the evening or afternoon.

The park just sits largely unused for the vast majority of most days and so long as respectful dialogue remains between dog owners/non-dog owners, and dog owners with poor behaving dogs remain respectful; there is no reason to oppose this change.
