I wanted to attend the community planning discussion last night because I heard that there was a possibility of moving the buses from Jenny to Willy permanently and I really wanted to be a part of that discussion. I couldn't make the meeting, but am emailing you anyway in the hopes that nothing has been decided.

I am very strongly against making this move permanent. As a pedestrian in the neighborhood, it has been difficult simply walking my dog down Willy because of the large numbers of people blocking the sidewalk while waiting for the bus. On Jenny, this wasn't really a problem because there were fewer people walking on the street. As someone who occasionally takes the bus, I miss the tranquility of waiting on Jenny. I've never had anyone yell at me out of a car window while waiting for the bus until now. As a driver, I have been patiently dealing with the increased traffic times and the lack of parking because I thought it would be over at the end of the construction period, but now I am worried that this is going to go on forever. I sat through two lights yesterday trying to get home from work simply because the bus was stopped and traffic was too heavy in the other lane for me to get around it. Meanwhile, the person behind me got frustrated, cut a car off to get around the bus, then made a right-hand turn in front of the bus from the left lane instead. Willy just isn't big enough to accommodate buses and cars during those peak traffic hours when we're already dealing with the bottleneck caused by the isthmus. I have also heard from some small business owners in the neighborhood that they are noticing a marked decline in business because they've lost all that street parking that they had relied upon until now. All of these things are concerning to me.

Thank you for your willingness to listen to individuals in the community while you make your decisions. I hope that the final result is something that will be beneficial for everyone in the neighborhood and not just convenient for some.
