

# PETITION FOR A SAFE AND CLEAN WORK ENVIRONMENT

The issue of “homeless” persons sleeping and camping on the front porch of the City-County Building has been a contentious subject recently and over the past 4+ years.

There have been 196 reported disturbances and fights in the past 24 months (on at least once occasion a County employee having to physically break up a fight in the lobby);

- Open drunkenness and other intoxications in addition to those with 32 reports leading to an EMS response;
- Large amounts of baggage and bedding cluttering up the porch at all hours of the day (even now it's acceptable as long as “at least one person is attending them”);
- Washing laundry in the public bathroom sinks, or attending to personal hygiene in these same sinks;
- Running extension cords down to the light post outlets at the street creating a tripping hazard on City-owned sidewalks and the steps of the CCB;
- Food storage attracting mice and bugs (often, food brought by well-meaning people ends up abandoned or torn to pieces and tossed all over attracting even more rodents);
- And, as has been more publicly reported, the number of people who urinate/defecate in and around the CCB (even after outdoor facilities were provided) creating a health hazard to employees and visitors alike.

What may not be seen clearly during business hours becomes abundantly clear when at times three dozen people crowd around the porch, often blocking the main doors until forced to get up so the building can open for business. Some stay throughout the day often wandering between different floors and accessing department offices without having any business there. Employees have been harassed, threatened, and subjected to a hostile work environment while law and medical resources continue to be drained.

With this in mind, the below signed hereby respectfully request that camping, sleeping, storage of personal effects, abandonment of personal property, panhandling, and long-term loitering with no obvious business to be conducted, be banned from the City-County Building.
