2. 31594 Community Services Committee, Fay Ferington

Fay Ferington reported that the committee reviewed the report, Strategic Vision on Equity and Social Justice Initiative, which lays out specific actions that the City of Madison plans to take in the near future. The information will be sent to members. She also reported that SAGE (Seniors Aging in a Gay Environment) will collaborate with Storycore to do personal life interviews.

Lauren Cnare estimated that every City committee had the workgroup's interim report on their agenda, and it was approved by the City Council. The recommendation for senior housing was of interest to CARPC (Capital Area Regional Planning Commission). Lauren attended an "8 to 80" conference in Chicago, where participants were encouraged to enhance their cities for all ages, and she mentioned a fair housing equity assessment that might be helpful in Madison.

**6.** 33492 Advocacy Focus for Committee: Affordable Senior Housing/Mental Health Impact on Housing

Christine Beatty spoke with Matt Wachter who will attend our July meeting. He is working on the low income section of the report and will soon turn to the issue of senior housing. Christine also reported that the 2015 City Capital Improvement budget may contain funds to advance senior housing and capture federal monies for 250 units of housing and owner occupied housing assistance. She remarked that many discussions are occurring on the committee's interest area.
