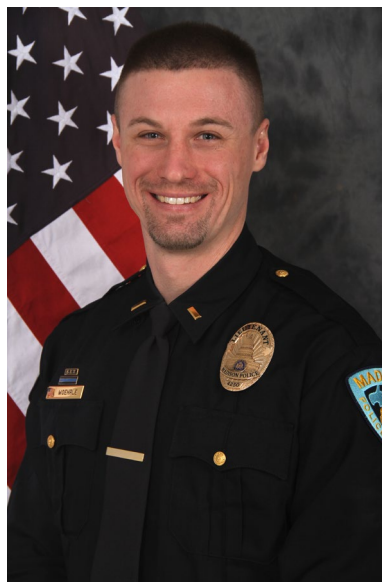
**Lieutenant Eugene Woehrle to Acting Captain**

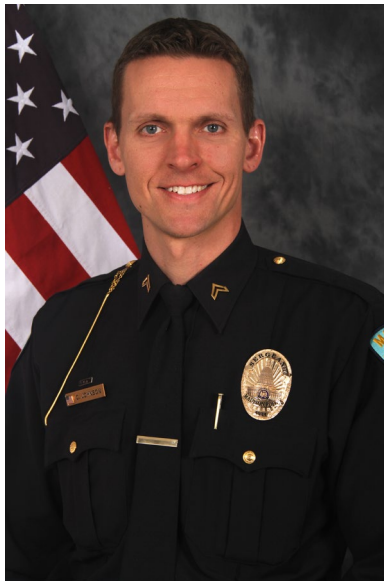
**Detective Sergeant Caleb Johnson to Acting Lieutenant**
