I just had a chance to review your application late yesterday. As mentioned in our pre-application meeting on 3/24/14, that football Saturdays is a separate and specific conditional use request. A request of this nature also requires a 30 day notice to the Neighborhood and Alderperson prior to making an application. I will discuss with staff this morning if your notice to the Neighborhood and Alderman sent April 23, 2014 is sufficient. If you have a separate notification that addresses the football Saturday operations please forward.
