Event Overview:

The Majestic has confirmed Swedish Indie Rock sensations Peter Bjorn and John for a performance at the Majestic Theatre on Friday August 26th. Both the Majestic and the band have expressed an interest in having this concert be a free event on King Street.

Peter Bjorn and John jumped to international stardom with their ubiquitous 2006 hit "Young Folks" known to some as simply The Whistle Song. The song received heavy airplay on 105.5. Triple M. They have recently released their follow up album, and the first single has been very well received and is also being played on Triple M.

The Majestic has had an interest for many years in producing outdoor events on King Street, both as paid and free programs. It is our hope that this will be a springboard to more outdoor programming in Downtown Madison in the coming years.

Event Zone:

The Event will encompass the entirety of the 100 Block of King Street. A concert stage will be placed on the corner of King and Doty. We believe this is a better location because of the natural slope of the street, creating far better sightlines for everyone. We believe that this will be the only street that is needed for closure, however it may be recommended to close East Main and South PInkney Streets within the outer loop of the Capitol Square.

We are hopeful that we will be able to utilize the surface parking lot at King and Webster as an emergency route for emergency vehicles.

Event Timeline:

6PM, August 25th: The 100 block of King Street becomes closed to vehicle traffic

9PM August 25th: Load in and stage construction begins

9AM August 26th: Load in of sound and lighting

2PM August 26th: Tentative Load In for Peter Bjorn and John 3PM August 26th: Tentative Peter Bjorn and John Soundcheck

4PM August 26th: Support Acts Load in and Soundcheck

5PM August 26th: Gates Open

7PM August 26th: First Band performs a 40 minute set. 8PM August 26th: Second Band performs a 40 minute set

9PM August 26th: Peter Bjorn and John perform a 75-90 minute set

11PM August 26th: Strict hard sound curfew

11PM August 26th: Load Out of Peter Bjorn and John, Sound and Lights and Stage

8AM, August 27th: King Street open again to vehicle traffic

Change of Licensed Premise:

The Majestic will apply to the ALRC for a Change of Licensed Premise. As this is a free event, the sale of beverages will be the only revenue source available to offset the costs of the production. The Majestic will be the only licensed vendor on King Street.

The Majestic will be responsible for obtaining all necessary insurance to satisfy City of Madison Risk Management, as well as for safe identification and distribution of alcoholic beverages.

Impact to Area Businesses:

Since the event is free, the street will remain open and businesses will remain open and restaurants would be able to utilize their sidewalk cafes.

It is our belief that the taverns in the area will see a dramatic increase in business as the concert ends.

Security Overview:

The Majestic in concert with private security and with limited assistance from Madison Police Department will be responsible for securing the event. As it is a free event with limited vending, we do not anticipate the need for a heavy security presence on the street. However, there will be no less than 15 security staff members for the duration of the event.

Marketing Plan:

We will market this show to various print outlets such as The Onion, 77 Square, Badger Herald and Isthmus. Additionally, we expect 105.5 Triple M to be the welcoming station for the show. The event will be rain or shine.

Recycling:

We will be asking the City of Madison streets division to provide recycling containers for the event. Post show, Majestic staff will work with City staff to clean the street of debris and dispose of it appropriately.
