

To properly establish, lay out, widen, enlarge, extend, construct, reconstruct, improve, or maintain a portion of the streets designated above, the City of Madison deems it necessary to reconstruct or change said street and acquire certain lands and interests or rights in lands for the project.

To effect this change, pursuant to authority granted under Section 62.22, Wisconsin Statutes, the City of Madison Orders that:
