SUBJECT: USA Climbing – Rollover request

Dear MTBEAAC members,

At our May 8 2018 meeting, we tabled the decision on rolling over the USA Climbing funding for 2022, due to confusion on multiple funding requests for 2020, 2021 and 2022.

Below is clarification on the rollover request:

- At our December 5 2017 meeting, we approved \$62,000 for 2020 USA Climbing and \$28,800 for 2021. The reason for the lower amount requested for 2021, was the balance remaining in the fund and our intention to bring forward the balance of the \$65,000 request in 2018.
- At our February 13 meeting, we approved \$36,200 for 2021 USA Climbing, which when added to the previously approved \$28,800, brought the total approved for 2021 to \$65,000 for 2021.
- Since our February meeting, we have shifted our two year-bid for the event to 2021 & 2022. Hence, the July meeting request to “rollover” the \$62,000 request for 2020 to 2022.
