This project involves the installation of approximately 1200 ft of sanitary sewer main on Todd Drive and the North and South Frontage Roads of the W. Beltline Highway. Water Utility will be installing approximately 500' water main on the South Frontage Road of the W. Beltline Highway just east of Landmark Place. This utility project is being done in advance of the Wisconsin Department of Transportation (WDOT) street reconstruction of the Todd Drive and the West Beltline Frontage Roads (north and south). The WDOT project includes the installation of several retaining walls which will be in conflict with sanitary sewer and water facilities. This City project will correct these conflicts in advance of the WDOT project.
