

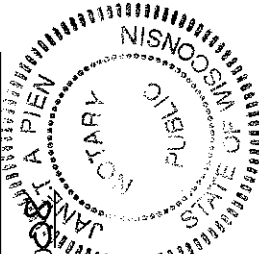
MAILING AFFIDAVIT - FINAL RESOLUTION CONCERNING ASSESSMENTS
