Staff provided an update on the discussions and actions of the Ad Hoc Landmarks Ordinance Review Committee.

There was a brief discussion about the upcoming CLG letter of intent deadline. Staff explained that the applications this year will be for the National Register nomination preparation for the Sylvan Ridge historic district if the neighbors are supportive and for the Phase II comprehensive historic preservation planning efforts. The Commission authorized staff to move forward with the CLG letters of intent as discussed.
