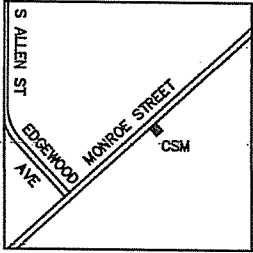

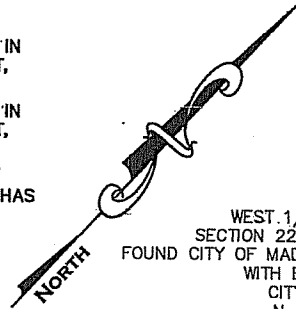

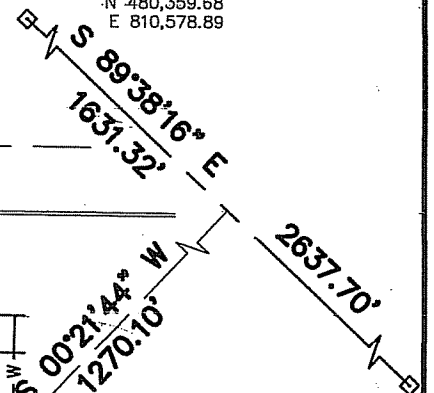

DIRECTION OF SURFACE DRAINAGE



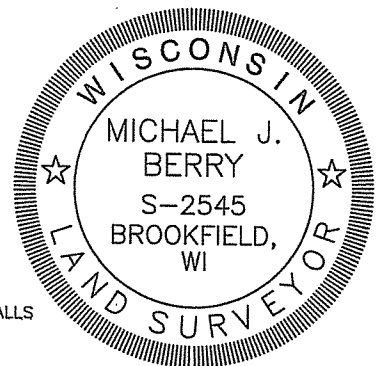
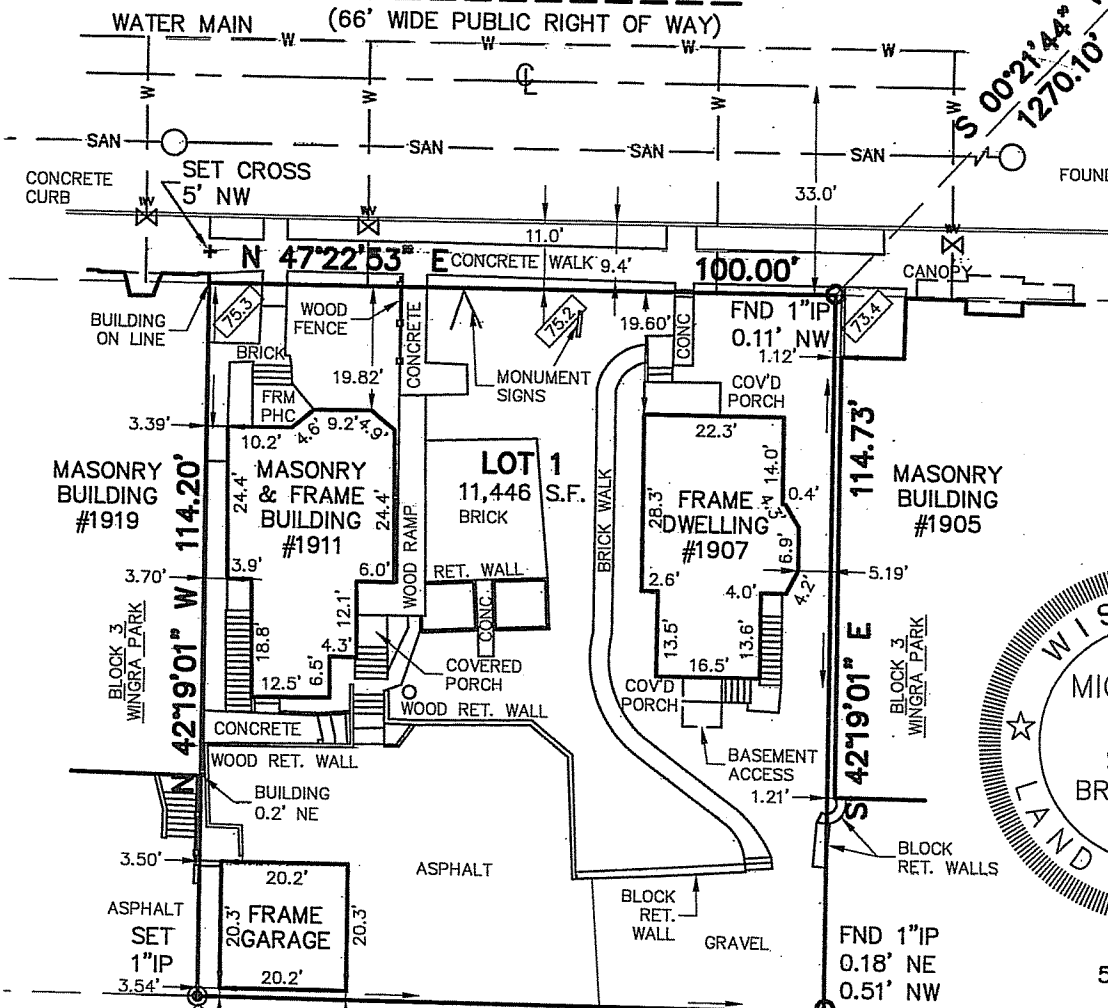

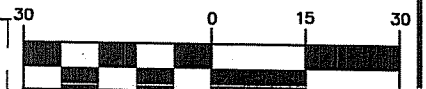
MONROE STREET

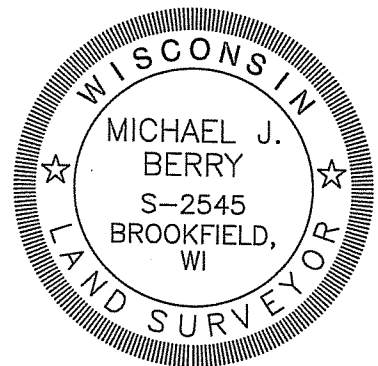
