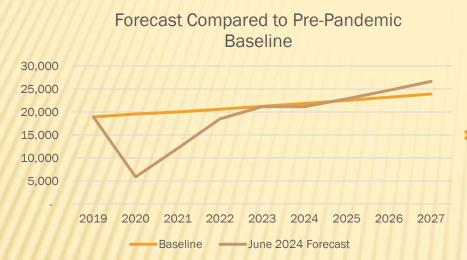

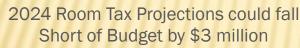

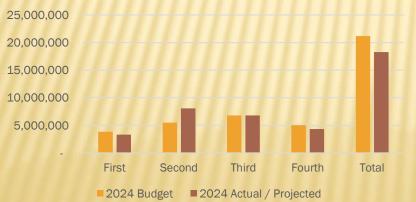

ROOM TAX REVENUES - MIXED NEWS





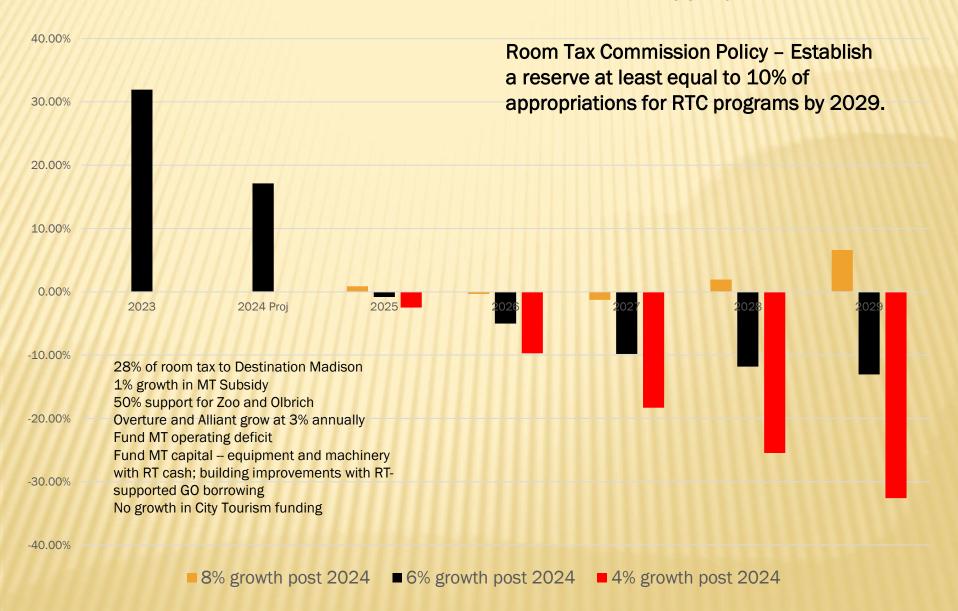


- Final 2023 \$21.1 million (up 14% from 2022) \$1.1m higher than February 2024 figures. Variance due to late payments throughout year.
 - 2024 Q1 -- \$3.3m (down 17% from 2023 Q1; 14% below 2024 Q1 forecast). 2024 Q1 up 1% compared to 2019 Q1. About ½ of reduction due to one vacation rental marketplace. Excluding on-line, collections down 3% from 2023 Q1
- 2024 forecast -- \$21.1m no change from budget (no increase from 2023 actual). Current model maximum estimate is \$19.3 million
- 2025 forecast \$22.2m up 5% from 2024; long-range includes 5%.
