REQUEST FOR FUNDS OR MAJOR CHANGES IN CURRENTLY FUNDED PROJECTS

Authorizing the provision of funds to assist Metropolitan Milwaukee Fair Housing Council (MMFHC) in providing testing of potential discriminatory behavior in

rental housing. (2008/06-C)

Metropolitan Milwaukee Fair Housing Council request \$30,000 for testing of discriminatory practices in response to request for proposals issued by CD Office in April 2008.

Authorizing the provision of Affordable Housing Trust Funds to assist Movin'
Out, Inc., with making accessibility improvements to one rental unit.
(2008/06-D)

Movin' Out requests \$6,000 in Affordable Housing Trust funds to make accessibility improvements to an existing rental property.

- Authorizing the provision of Scattered Site Funds to assist Movin' Out, Inc., with acquisition and rehabilitation of a property with two rental units. (2008/06-E)

 Movin' Out requests \$49,200 in scattered site funds to acquire and rehab a duplex in a scattered site area to be used as affordable rental housing.
- Authorizing the provision of Emergency Shelter Grant (ESG) funds to assist
 Interfaith Hospitality Network (IHN) to renovate Office space to serve families
 in ways that address City Community and Neighborhood Development
 Objectives.

IHN requests funds to make some leasehold improvements in its office space.

Authorizing the City to accept an Emergency Shelter Grant (ESG) award from the State of Wisconsin, authorizing the Mayor and City Clerk to sign agreements with various agencies to implement projects as part of the ESG award. (2008/06-F)

The City received \$397,413 in Emergency State Grant (EGS) funds from the State of Wisconsin in response to an application submitted by the City on behalf of consortium of agencies. The City will accept these funds and enter into contracts with community based agencies to implement homeless projects to further CD office objectives.

A CD staff member, Pam Rood, who administers the American Dream Downpayment Initiative Program, may encounter situations where loan applications are referred by Britta Miller, a loan processor for Wisconsin Community Bank and step-niece of Ms. Rood, which would fall within potential conflict of interest rules promulgated by the Federal Department of Housing and Urban Development. Ms. Miller is paid an hourly wage and does not receive a commission for loans processed, which reduces a potential financial gain for Ms. Miller. The CD Office has procedures in place for review of loans processed by Ms. Rood, which would mitigate a conflict of interest.

The Commission adopted an operating policy that permits CD Office staff to pursue with

HUD exceptions to the Federal Conflict of Interest rules as permitted by Federal regulations, unless the Commission takes action to prohibit such a request in specific cases presented to the Commission. HUD makes the final decision on all such requests for an exception.
