A SUBSTITUTE ORDINANCE  Amending Section 1.08(3)(a) of the Madison General Ordinances to modify, repeal and recreate bail deposit amounts for various ordinance violations, amending Sec. 23.35(2) of the Madison General Ordinances to increase the forfeiture for permitting animal to cause injury by bite, amending Section 24.09(6) of the Madison General Ordinances to be in conformity with state statute, amending Section 34.26 of the Madison General Ordinances to modify the forfeiture range for removal or tampering with Fire Protection Systems.

DRAFTER'S ANALYSIS: This ordinance amends Section 1.08 to create uniformity among bail deposits for Section 9.13; increases the bail deposit for Section 10.05(6)(a), failure to obtain a permit for excavation of any public right-of-way; increases the bail deposit for Section 23.06, damage to property and Section 23.35, permitting animal to cause injury and Section 23.54, retail theft; and amends various additional bail deposits. It amends Section 24.09, light motor vehicle noise, to be in conformity with controlling state statute. This ordinance amends parts of Section 1.08 to create uniformity among bail deposits listed in the police bail book and Section 1.08.  The Common Council of the City of Madison do hereby ordain as follows:  1. Subdivision (a) of Subsection (3) entitled "Schedule of Deposits" of Section 1.08 entitled "Issuance of Citations for Violations of Certain Ordinances and Providing a Schedule of Cash Deposits" of the Madison General Ordinances is amended by creating, amending or repealing therein the following:

- 2. Subsection (2) of Section 23.35 entitled "Permitting Animal To Cause Injury By Bite" of the Madison General Ordinances is amended to read as follows:
- "(2) Any person violating this section shall upon conviction thereof be subject to a forfeiture of not more than \$200 five hundred dollars (\$500)."
- 3. Subsection (6) entitled "Sound Producing or Amplification Devices" of Section 24.09 entitled "Light Motor Vehicle Noise Control" of the Madison General Ordinances is amended to read as follows:
- "(6) Sound Producing or Amplification Devices.
  - (a) Notwithstanding the noise limit expressed in Sec. 24.09(4) of these ordinances and except as provided in sec. 347.38(1), Wis. Stats., no person may operate or park, stop or leave standing a motor vehicle while using a radio or other electric sound amplification device emitting sound from the vehicle that is plainlyclearly audible under normal conditions from a distance of 75 (fifty (50)) or more feet, unless the electric sound amplification device is being used to request assistance or warn against an unsafe condition. This subsection does not apply to any of the following:
    - 1. The operator of an authorized emergency vehicle, when responding to an emergency call or when in the pursuit of an actual or suspected violator of the law or when responding to but not upon returning from a fire alarm.
    - 2. The operator of a vehicle of a public utility, as defined in sec. 496.01(5), Wis. Stats 11.40(1)(a), Wis. Stats.

- 3. The operator of a vehicle that is being used in a community event or celebration, procession or assemblage.
- 4. The activation of a theft alarm signal device.
- 5. The operator of a vehicle that is being used for advertising purposes.
- 6. The operator of a motorcycle being operated outside of a business district.
- (b) Any owner, operator, or agent having control over the subject equipment violating any provision of this section shall, for the first violation, be subject to a forfeiture of not less than tenforty dollars (\$1040) nor more than one hundredeighty dollars (\$10080); for the second and subsequent violation within one year, be subject to a forfeiture of not less than fiftyone hundred dollars (\$50100) nor more than two hundred dollars (\$200); and for the third and subsequent violations, be subject to a forfeiture of not less than one hundred dollars (\$100) nor more than five hundred dollars (\$500)."
- 4. Subsection (2) of Section 34.26 entitled "Removal or Tampering With Fire Protection Systems" of the Madison General Ordinances is amended to read as follows:
- "(2) Any person violating this section shall be subject to a forfeiture of up to <u>five hundred dollars (\$100500)</u> for the first violation, and not less than <u>one hundred dollars (\$100)</u> nor more than <u>one thousand dollars (\$3001000)</u> for the second or subsequent violation within a three (3) year period."

## **EDITOR'S NOTE:**

1. New or amended bail deposits must be approved by Municipal Judge prior to adoption. These deposits have been so approved.
