**Memo:** Healthy Retail Access Work Group Funding Recommendation – *Go-oh Groceries*

Members of the Madison Food Policy Council,

The Healthy Retail Access Review Team met with Jerreh Kujabi and Samba Baldeh (Owners/Reps – Go-oh Groceries) on Wednesday, October 4<sup>th</sup>, 2023 to discuss their proposal seeking \$136,800 in Healthy Retail Access Program (HRAP) funding. This funding would assist them in the final start-up costs associated with opening a small community grocery store in the former Visions Night Club building at 3554 East Washington Avenue. This proposal requests funding for costs related to inventory procurement and final start-up costs (professional fees, shelving, point-of-sale system).

As noted in past funding awarded to the project in early 2021, the Hawthorne, Truax, and Carpenter-Ridgeway neighborhoods have distinct geographical challenges as it pertains to residents' access to healthy food. There is a full-service Hy-vee Grocery store a half-mile away from the proposed Go-oh Grocery store site. However, for residents of the neighborhood, particularly for those without reliable access to a vehicle, it is a somewhat daunting task to get to that store because of the necessity to cross East Washington Avenue or Stoughton Road (and in some cases both). Go-oh Groceries, while intending to have a larger trade area than just these adjacent neighborhoods, will offer a safer and more convenient food retail choice to residents of these neighborhoods. It also has the added benefit of taking what many in the neighborhood and city considered to be a somewhat troubled location that conflicted with the typical structure of an established residential neighborhood, and converts it into a community asset providing healthy food options to a diverse clientele.

In the face of rampant inflationary cost escalations – which have increased project costs by almost 100% – members of the Healthy Retail Access Review Team highly recommend that the requested \$136,800 in HRAP funding be awarded to Go-oh Groceries to assist with final start-up costs related to opening a community grocery store serving the Hawthorne-Truax-Carpenter-Ridgeway neighborhoods.
