The Common Council of the City of Madison do ordain as follows:

1. Paragraph 3077. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

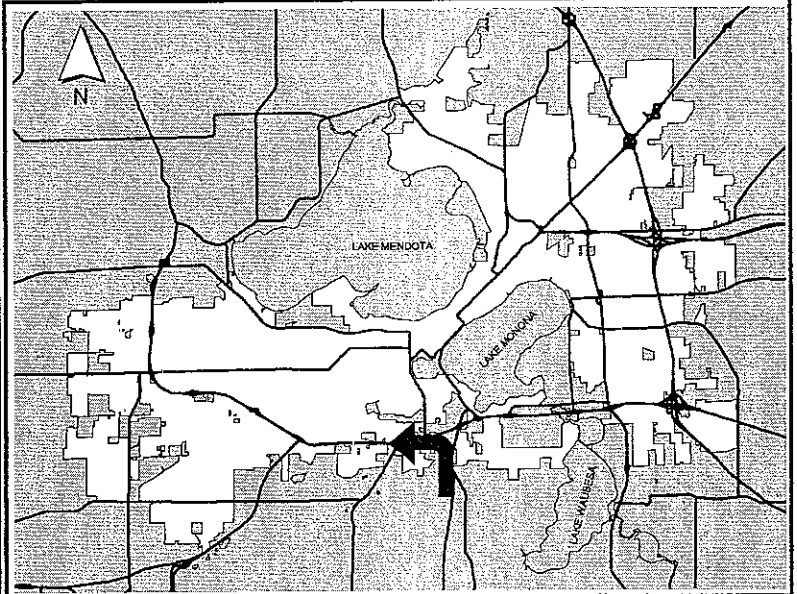

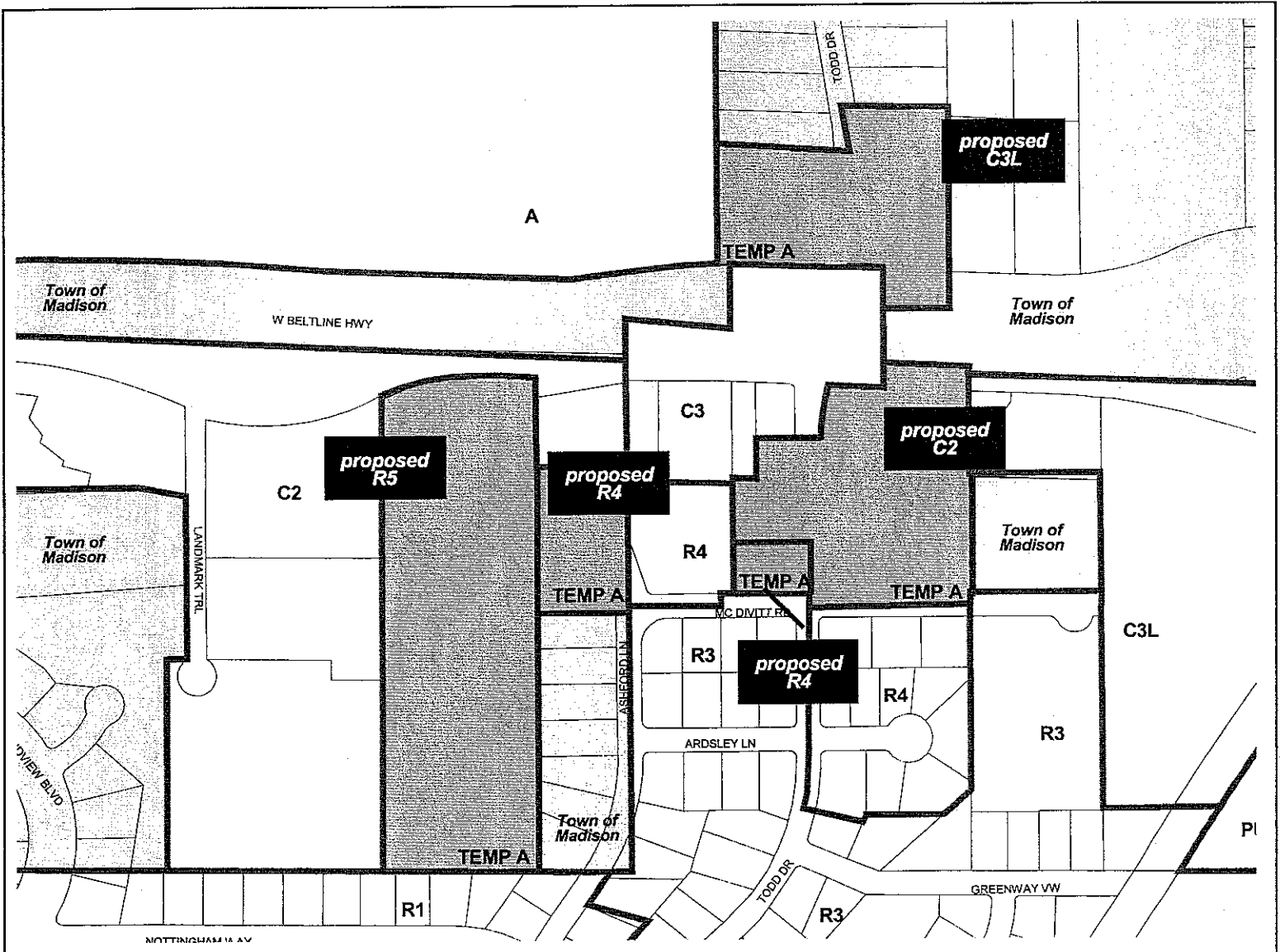
