 A motion was made by Jurewicz, seconded by January, to Approve the four top scoring applicants to be finalists. These are Ally Wilber & Helen Klebesadel, Nipinet Landsem, Audifax, and Amy Zaremba. Finalists will receive a \$1000 design fee for their initial mural designs that will be brought back to MAC for a final round of scoring to pick the artist that will receive the mural commission.
