Dear Alder Vidaver,

We have become aware that City Engineering abruptly removed the installation of sidewalk on the south side of the west end of Harvey Street from the Schmitt Place and Harvey Street Reconstruction and Sidewalk Project. As a result, a sidewalk gap on Harvey Street between 3325 Harvey Street and Blackhawk Avenue could remain unfilled for many years. The time to fill in the Harvey Street sidewalk gaps is now while the city has an active project. It takes far too many years for the city to address these gaps as part of street improvement projects.

Sidewalk should also be constructed on the east side of Blackhawk Avenue between University Avenue and Harvey Street at the earliest opportunity in order to enable more continuous safe off-street movement.

We, the undersigned, petition the Madison City Council to require that sidewalk be constructed between 3325 Harvey Street and Blackhawk Avenue to fill in the missing gap on the south side of Harvey Street as part of the project.














