# **DISCUSSION BY MEMBERS**

Staff distributed materials supplied by Tyson Kindstrom of STO addressing durability, water resistance and other properties of the product based on scientific studies and data. The Commission determined that it desired to delay any discussion on its policy until adequate time had been provided to review the materials as distributed with staff to schedule the idea for further discussion at the meeting of February 8, 2006. Staff noted to the Commission a request to discuss the EIFS issue with product representatives would be delayed until the Commission had finalized its discussion. The Commission requested that staff acquire additional information that provides for a comparison to other materials and products like real brick, block, stone panels, fiber cement and other materials relative to durability at street level.
