1. [32002](#) 2013 Food Cart Reivew - Which may include results, duration, site assignments, numbers of applicants, history, waiting list, its future.

2. [32003](#) ConMall/Concourse Site Request Deadline
This year, two high-scoring applicants changed their 2014 site requests at the last minute, displacing others. It also makes it more difficult for the Street Vending Coordinator to finalize site assignments. I would recommend that the annual September 1st application deadline be designated as the last date to request sites for the forthcoming year. Regs - III, A.
3. [32004](#) Consider a More Specific Definition of "Sabbatical" with Regard to Time Taken Off from Vending and Return to Removal from the Seniority List After Two Consecutive Years Without Purchasing a Vending License. Regs - IIF., a. and IV., A.1.
4. [32005](#) Consider an "Umbrella" License for Mall/Concourse Food Vendors
This could be made available at an annual cost to Mall/Concourse Food Vendors at \$400, similar to the generic Bar Manager License. For vendors who purchased it, this license would allow employee-vendors to come and go and would replace the individual Street Vendor Licenses (\$150 each) for the cart holding the umbrella license.
