To Whom It May Concern:

My name is Michael Bruce and I manage a small community resource center on Russett Rd. Specifically, I am employed with Dane County Department of Human Services in the Joining Forces for Families Initiative. I am writing this letter to strongly support the addition of a neighborhood farmer's market.

Our office routinely works with over 100 families in a given week, and the vast majority of service requests made revolve around basic human needs. Families routinely come to our office in immediate need of assistance to feed their children. Towards this end, we are routinely directing families to one of 2 area food pantries, and/or offering emergency food supplies from our office.

One issue that consistently comes up is the lack of any available produce and other perishable food items. Routinely families get boxes of cereal, noodles, tomato sauce, macaroni and cheese, and a variety of canned goods. Only occasionally, is some sort of meat available to families, and all of the area food pantries have a one time per month limit for families. Compounding this scenario, there is no nearby grocery store within 3-4 miles of the Balsam, Raymond, Russett corridor. Along these lines, families consistently go without fresh produce for themselves or their children. The addition of a local farmers market would immediately remedy this situation.

Additionally, a neighborhood farmer's market would build a sense of community and connectivity. Approval of this grant would not only help to fill an important need in the community, but would also bring neighbors together; a small investment with a very large return.

I am writing in support of the REAP Food Group's grant application to start a farmer's market on Madison's south west side. As a nutrition educator for UW Extension's Wisconsin Nutrition Education Program, I understand the value of produce in all people's diets.

I have been a nutrition educator on Madison's Southwest side for seven years and food security has become a serious issue for many families living there. During the past few years, the southwest side has seen a dramatic increase in the incidence of poverty and there is a lack of resources to address the needs of people living there. For example, there is currently no place within walking distance for residents to access affordable food. A farmer's market would not only provide access to nutritious food, but would give residents a place to meet others and feel less isolated. The farmer's market would accept Food Share (food stamps) and WIC vouchers. This would ensure access to fresh produce to all residents. A farmer's market would also be a wonderful opportunity for the Wisconsin Nutrition Education Program. My support of this grant includes me providing nutrition education at the market including food preparation demonstrations with market produce and basic nutrition education.

I strongly encourage you to accept REAP Food Group's request for funds to support access to fresh local produce.
