Captain Lengfeld from the Madison Police Department shared with the committee information regarding the CARD Project work plan which is a grant that will be used to focus on in-depth compliance on those over 600 establishments in the City that have alcohol licenses as well it can be used for "party patrol". He mentioned that establishment checks generally occur two times per year, but that this grant will allow officers additional time to focus on checks when he named a few items such as underage drinking, compliance of license requirements, ratio of the number of people in the establishment to the number of bartender's, capacity, bouncer/or id checker, and is the establishment in need of repairs. Regarding "party patrol" this grant would allow officers additional resources when large events occur such as Mifflin Street Party or Halloween.

Alder Skidmore made a motion to accept the report. Alder Phair seconded the motion. The committee voted unanimously to accept the report.

25037 Alder Skidmore will report on the Dane County 911 Center Board.

Alder Skidmore shared with the group that the County would more than likely need to file for an extension given that the radio project has not begun and that the contract will default at the end of this year. He also mentioned that Assistant Chief Keiken from the Madison Fire Department is a new member on the 911 Board.
