





Dear Outdoor Eating Area Operator:

Last year City of Madison staff were asked by neighborhood residents and Alderpersons in the vicinity of Camp Randall Stadium to review the applications that have been approved over the last ten years for outdoor eating areas that operate on Saturdays of University of Wisconsin home football games. Some of these businesses still operate, others do not.

In an effort to get to common ground between nearby residents and business operators, the City intends to apply the following uniform conditions beginning this fall for all existing approved and future applications.

HOURS OF OPERATION

For University of Wisconsin, or Green Bay Packer afternoon football games the outdoor eating area shall be open no later than 8 p.m. For games with kick-off after 5 p.m. the outdoor eating area shall be open no later than 10 p.m.

2. OUTDOOR MUSIC

Outdoor live or amplified music or sound shall not be permitted before 10:00 a.m. and shall be allowed only if already specifically approved by the Plan Commission at the time of granting your original conditional use permit. This is one of the biggest issues for nearby residents. Please try to keep music volume at a reasonable level. The City will be applying the decibel level limitations in the provisions of the proposed noise ordinance if complaints are received regarding the operation of any outdoor facility that has music or amplified sound (copy attached). If complaints are received that are found to exceed this level, we will schedule a new public hearing before the Plan Commission which may result in the modification or revocation of your conditional use permit.

3. FENCE ENCLOSURE, SECURITY GUARDS, LITTER CONTROL AND PORTABLE TOILETS

If you have a license to sell alcohol in an outdoor eating area, the Alcohol License Review Committee has established conditions for operation for these applications that involve fencing, security guards, toilet facilities, litter, etc. All businesses that sell alcohol must comply with the requirements imposed by the Alcohol License Review Committee at the time of issuance of your original application to expand or change your licensed premise to include the outdoor eating area.

4. STADIUM CONCERTS

If you open the outdoor eating area for any proposed stadium concerts (U2, Rolling Stones, etc.) the outdoor eating area shall close no later than 1 hour after the start of the concert and remain closed for the evening.

These guidelines will be applied to all businesses operating outdoor eating areas operating near the stadium on University of Wisconsin or Green Bay football game days.

We are sending this letter out to all businesses that operate outdoor eating areas well in advance of the first 1998 Fall football game to allow time for you to plan your business operations.

Those businesses having Plan Commission conditional use approvals which either don't address some of the proposed uniform standards or whose requirements vary slightly from these uniform standards will have the conditions amended through the minor alteration process with a waiver of the application fee. In the event that you feel these uniform standards should not apply to your situation these fee will also be waived so that you can return to the Plan Commission for a public hearing and review of your full conditional use permit.

Dear Mr. Franklin:

The Plan Commission at their September 14, 1998 meeting did not approve your request to remain open until 12:00 a.m. on days of University of Wisconsin home football games or other stadium events. The Plan Commission did not find that the conditional use standards were met. The Plan Commission reaffirmed the uniform conditions being applied to outdoor eating areas that operate on Saturdays of UW home football games. Those conditions were as follows:

- 1. Hours of operation for University of Wisconsin and Green Bay Packer afternoon football games. The outdoor eating area shall be open no later than 8:00 p.m. For games with kick-off after 5:00 p.m. the outdoor eating area shall be open no later than 10:00 p.m.
- 2. Outdoor music. Outdoor live or amplified music or sound shall not be permitted before 10:00 a.m. and shall be allowed only if already specifically approved by the Plan Commission at the time of granting your original conditional use permit.
- 3. Fence enclosure, security guard, litter control and portable toilets. The Alcohol License Review Committee has established conditions for operation of these applications that involve fencing, security guards, toilet facilities, litter, etc. Your business will need to continue to comply with the requirements imposed by the Alcohol License Review Committee at the time of issuance of your original application for an outdoor eating area.
- 4. <u>Stadium Concerts</u>. If you open the outdoor eating area for proposed stadium concerts, the outdoor eating area shall close no later than 1 hour after the start of the concert and remain closed for the evening.

This Plan Commission action modifies and updates your conditional use approval with the above conditions. All other conditions contained in your original conditional use approval shall remain in effect. Please contact me or George Carran, Zoning Administrator at 266-4635 if you have questions.

Re: Stadium Bar Conditional Use

Thank you for meeting with us last Thursday to discuss the Stadium Bar issues which are scheduled to be the subject of a Plan Commission Hearing next Monday, January 26th. At our meeting, you asked that we present our position on those six items which you referred to in your October 13, 2008 memo as "problems with conditional use". Before we address specific proposals for dealing with those issues, I wanted to clarify a few things.

First, we do not concede that there have been any violations of the conditional use permit. We are willing to modify the conditional use permit and otherwise undertake the activities outlined in this letter in order to resolve issues that the City has raised. We are not, however, conceding that any violations exist nor are we waiving any of our rights. Whatever we propose in this letter is for settlement purposes only.

Secondly, we will appear at the public hearing next Monday. Any attempt to revoke or modify our conditional use permit in a manner other than as stated in this letter will, however, likely be resisted by us and we will request that the hearing be held over so that we can be afforded all of our due process rights.

Hopefully, the foregoing issues will be moot and we will be able to agree as follows:

- 1. The issue of what constitutes "Special Event" at Camp Randall Stadium. We will agree that a reduced sized beer garden as shown on the previously submitted site plan would be available to us for the University of Wisconsin spring football game, the Crazy Legs run, the WIAA High School football championships and other similar events that may arise in the future. Football Saturdays and outdoor Camp Randall concert events could use the full-sized beer garden.
- 2. Unapproved alterations to the site plan during certain events. We have recently submitted to you new site plans that will govern the site so the issue of unapproved alterations will go away.
- 3. Developing a common understanding in regard to "Football Saturdays" activities. We have submitted for your approval a management plan that sets forth Football Saturday activities.
- 4. Use and volume of outside amplified sound. We have shown on the site plan the location of all outdoor speakers. Our management plan also addresses this issue.
- 5. Restrictions on the hours of Football Saturdays' use of the property. We acknowledge and pledge to comply with such hours of operation. We understand that there will be (and we welcome) a discussion of expansion of those hours for night football games.
- 6. Failure to comply with conditions applied to previous approvals including construction of a decorative fence along Monroe Street. We have addressed any such issues in our site plan and will be constructing a decorative fence along Monroe Street sometime this summer.

Please let us know if you have any questions about any of our responses. From our standpoint, the major issue revolves around the proper definition of "Special Events". We are hopeful that the proposed solution contained in this letter will resolve that issue. As noted previously, however, we believe that we have the right to have our full beer garden open on such special events and nothing contained in this letter


shall be construed as implying that we believe that there are further limitations on those rights.



Subject: Football Game Day Management Plan

OPENING PROCEDURE:

Game time: 11:00 a.m.

- Opening staff arrives at 6:30 a.m. Beer garden set-up begins immediately.
- All staff members wear Stadium Bar uniforms.
- Beer garden is fully set-up by 8:30 a.m.
- Food and beverage service begins @ 9:00 a.m.
- Music and television coverage begins @ 10:00 a.m.
- Security (Dane Co. Sheriffs) arrive 2 hours prior to kick off.
- Stadium Bar employees a minimum of 10 Sheriffs and a maximum of 12 Sheriffs per game.
- 2 Sheriffs at each gate with counters and head phones to keep in contact with management staff inside and outside. Sheriffs are responsible for I.D. check at each gate. Two Sheriffs equipped with head phones are on constant roving patrol throughout the garden and the building.
- One Dane Co. Patrol car available behind building for use if necessary.
- At game time music converts to coverage of the football game with music only during the commercials and half time.
- Following the game music resumes until 7:45 p.m.

CLOSING PROCEDURE:

- Outdoor food and beverage service stops at 7:45.
- Music stops at 7:45.
- Announcements are made that the garden has closed and everyone must leave the garden promptly.
- Sheriffs assist in clearing the garden to ensure everyone has left the garden before 8:00 p.m.
- Sheriffs remain at the gates to ensure no beverage containers leave the property.
- After clearing the property, sheriffs help monitor the capacity inside and monitor the exterior to ensure that it is only used as a parking lot.
- Employees normally average one hour to disassemble the garden serving areas, sweep and clean the entire parking lot and ensure all trash is placed in the proper area.

VARIOUS GAME TIMES:

- Opening and closing procedures are the same for 2:30 games.
- For night games (games beginning after 5:00 p.m.) the garden opens at 11:00 a.m. and closes at 10:00 p.m. in accordance with the football day only conditional use permit.

FACILITIES:

- 24 portable toilets are provided for the public during all hours of garden operation.
- Separate facilities are provided for the staff and sheriffs.
- Hand wash stations are provided adjacent to all portable toilets.
- Tents and heat are provided for games during inclement weather.

FOOD & BEVERAGE:

- Food is served during all hours of operation.
- Multiple non-alcoholic beverages including water, juice and soda are available during all hours of operation.
- Outside bar service includes a compliment of premium liquor and a varied selection of domestic beer, micro brews and imports.
- Inside bar is a full service bar with choices similar to our daily operation.

ENTERTAINMENT:

- Feature a 15' LED screen to broadcast football games throughout the day in addition to our four permanent outdoor televisions.
- Elevated stage with a D.J. playing music and free, give-away promotions (i.e. hats, t-shirts, sweatshirts, back-packs, tickets, etc.)
- Sound levels are monitored and are in accordance with conditional use permit.

CAPACITY MANAGEMENT:

- Dane Co. Sheriffs at each gate, with counters, to monitor the flow of people in and out of the garden to maintain a maximum capacity of 2416 people.
- In addition, the garden is monitored and managed by overview from the stage. From this vantage point management can detect and correct bottlenecks and problem areas. Stadium Bar management communicates with the Dane Co. Sheriffs to stop and start admissions at various gates; maintain a "1 in 1 out" scenario, or stop admissions and start lines depending on the distribution of people within the garden.
- Same procedure applies inside. All seven exterior doors are opened to facilitate the flow of people in and out of the building.
