#### **NEW BUSINESS**

#### 1. <u>19766</u> Briefing on Overture Center for the Arts

Tom Carto gave a briefing about the current governance structure of Overture and the proposed government ownership/private management model proposed for Council consideration.

(Sober) Q: Will the private non-profit that will run Overture will include the same members as the MCAD Board.

A: The 201 State Foundation will assume management with an independent and new board. (Sober) Q: What changes in programming do you anticipate?

A: More promoter activity particularly in Capitol Theater. More non-performance events such as weddings and other business opportunities. We want to target more underutilization of Overture in the summer months. We may including a summer camp. The Tommy awards have been very successful, we'll continue widespread community participatory events such as this HS Musical competition.

(Rummel) Q:What is the vision for Overture? Where is the grass roots?

A: Our roots are getting deeper. The Wisconsin Bookfest, The Wisconsin Film Festival, UW Freshman 1st Night, Forward Music Festival, these community partnerships have all deepened in recent years. We envision Overture as a national destination. Madison is already branded as a creative place. Overture could make Madison the next Aspen.

(Sober) Q: What are the prospects for a capital campaign?

A: Whoever ends up with Overture will have to run one, definitely.

(Farley) Q: What is MAC's role?

A: You already offer many of our resident groups partner grants for their educational and outreach programs which we appreciate and hope to continue.

(Unattributed) Q: Could there be an exposition district formed with the Alliant Center?

(Klehr) Q: How will the private entity affect your resident tenants? Will the resident companies grow?

A: Yes, there is plenty of capacity.

(Klehr) Q: Is there an opportunity for more resident companies?

A. Yes

(Unattributed ) Q: Will you raise the rent?

A: It wouldn't be helpful to significantly raise the rent. We anticipate raising the rent 1% per year.

Discussion followed his presentation including a call from commissioners to hear from more resident and non-resident users of the facility as well as patrons. "Overture is a business operation and that is taking 'center stage'" said Commissioner Madera. Commissioners concluded that they represent the voices of artists and the arts community and they would like the opportunity to have that community inform the decision making process.
