*The City of Madison has a quota of 407 Class B Combination Liquor & Beer licenses under state law. There are 44 Class B Combination Liquor & Beer licenses available under this quota. The city has granted 39 of its 82 Reserve licenses and 324 of its 325 Grandfathered licenses.
