Hello Emily;

Please pass to PSRC and/or to Deb Julian...(and I am CC'ing MPD representatives because I'll be suggesting their involvement in some of the issues mentioned).

Following are some more notes for the PSRC in response to the proposed subject matter at the end of this thread. I'm assuming these may or may not come up in the meeting in April that I'm invited to:

Request from PSRC: The PSRC would like information on the data available from the CAD to track MPD activities, individually by officer and collectively. Also of interest would be total calls taken daily/monthly/yearly for City PD and City Fire and as a percentage of total County. A: MPD activities, by officer and collectively, would best come from the MPD records management system (RMS). Please contact me if MPD's RMS is unable to produce the information so that we can discuss your request in detail and so that we can respond to it efficiently and effectively. We can get you totals calls (I will assume a call is a "call for service"; that is, not phone calls, but requests (phone calls or texts) that become a dispatchable incident). I will provide a representative snapshot that will show MPD and MFD CAD incidents as a percentage of the total PSC dispatches.

Request from PSRC: There will also be discussion of the recommendations made by the OIR Group regarding dispatch, specifically: regular quarterly training by MPD; scenario-based interagency training; review of dispatch communications after critical incidents including dispatch manager participation. There may also be questions on regular training for calls involving mental health and opioid crisis. A: The OIR report was not addressed to the PSC nor was a copy provided to us (partial information provided to me last week by MPD after I requested it). Questions regarding this document should be addressed by MPD representatives. I can brief the committee on the status of upcoming training from NAMI regarding Critical Incidents (involving mental health issues). And, I can provide answers to questions regarding the protocols used for phone/text calls involving overdoses.

Request from PSRC: Please advise whether or not a committee has been established to improve MPD/PSCC relations, or there is a continuation of utilizing workgroups instead. A: A work group comprised of MPD officers and PSC Communicators has been suggested by MPD (a few months ago) and has been agreed to by PSC, but it has not yet been formed. Other, effective work groups have been formed, as I mentioned in last year's meeting. I can brief on those at the meeting.

Request from PSRC: We would also appreciate a brief summary of your report to the PSCAC from January and preview of March. A: I will present a copy of the most recent quarterly report to my oversight body (the Public Protection and Judiciary Committee of the County Board) and will respond to questions. It is the same report I provide to the PSC Advisory Commission. The PSCAC does not meet in March; their next meeting is in mid-April.

For future meetings, please provide notes on requested discussion items such as were provided this time. They are helpful, especially if provided far enough in advance to provide time for preparation (or in this case, also, a response).
