The committee finds that Logans Madtown LLC through their agent that they do not wish to contest the facts of the case.

An offer of proof was requested from ACA Zilavy.

The record will remain open for 15 days. to allow Logans Madtown LLC to surrender their Class B Combination Liquor & Beer license. If a voluntary surrender does not occur, ACA Zilavy requested that the City revoke the license. Mr. Mais had nothing to add.
