Furthermore, the above-described land shall be subject to all of the following terms and conditions as set forth in Section 41 of the Madison General Ordinances, to-wit:

That every owner of the property shall protect the improvement against exterior decay and deterioration; keep the improvement free from structural defects; and maintain interior portions of the improvement, the deterioration of which may cause the exterior portions of such improvement to fall into a state of disrepair.
2. That every owner of the property may not allow the landmark to undergo demolition by neglect.
3. That every owner of the property shall submit all exterior alterations to the landmark or landmark site including land divisions to the Landmarks Commission of the City of Madison, Wisconsin for approval before any work commences or permits are obtained.
4. That every owner of the property shall submit all requests for the demolition of any buildings on this site to the Landmarks Commission of the City of Madison, Wisconsin for approval before any work commences or permits are obtained.
