Please move to refer legistar item #46640 to PBMVC. This item has not come in front of PBMVC to date and no discussion or deliberation on cross section alternatives has occurred. Any action of the Board of Public Works to recommend approval of the street geometry should come following deliberation and a recommendation from PBMVC as per their charge in Madison General Ordinance 3.14(6)(g)(2):

**The Pedestrian/Bicycle/Motor Vehicle Commission shall consider all traffic policy matters, including but not limited to, traffic safety programs and projects, speed zones, one-way streets, traffic signals, stop and yield signs, railroad-street crossing protection, street markings, street lighting, commercial parking lot and driveway design, street access control, median breaks, traffic channelizing devices, heavy traffic routes, mass transit ways and preferential lane use, turning restrictions and limitations, parking restrictions, **geometric design and redesign of streets**, transportation and traffic planning and plans, transportation impact studies, vehicle use permits and any other policy matters pertaining to the physical and operational aspects of traffic **and may in accordance with adopted criteria and standards receive and approve or deny requests for changes in these items.****

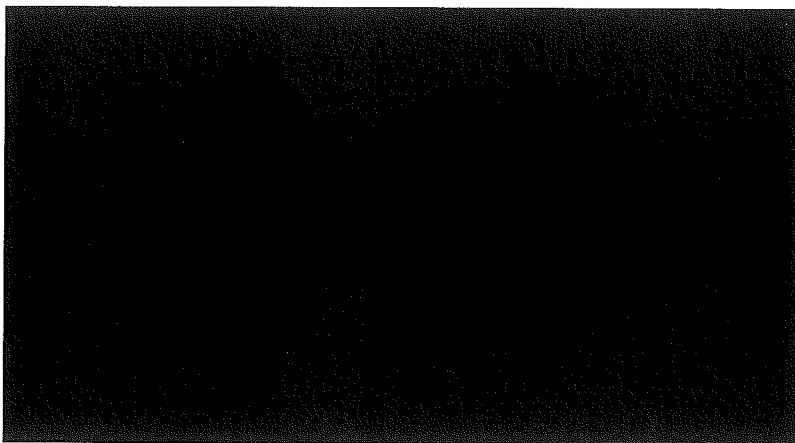
