The building that houses Cielo runs from 118 State St. to 116-118 N Carroll St. It includes a first floor grill and bar, which includes coolers for chilled beverages, and speed rails holding liquor bottles. The basement runs from State to Carroll St as well and houses 2 walk-in coolers for beer storage and ample space for holding reserve liquor. The basement coolers are well out of reach to the general public. Outdoor seating is a future possibility.
