

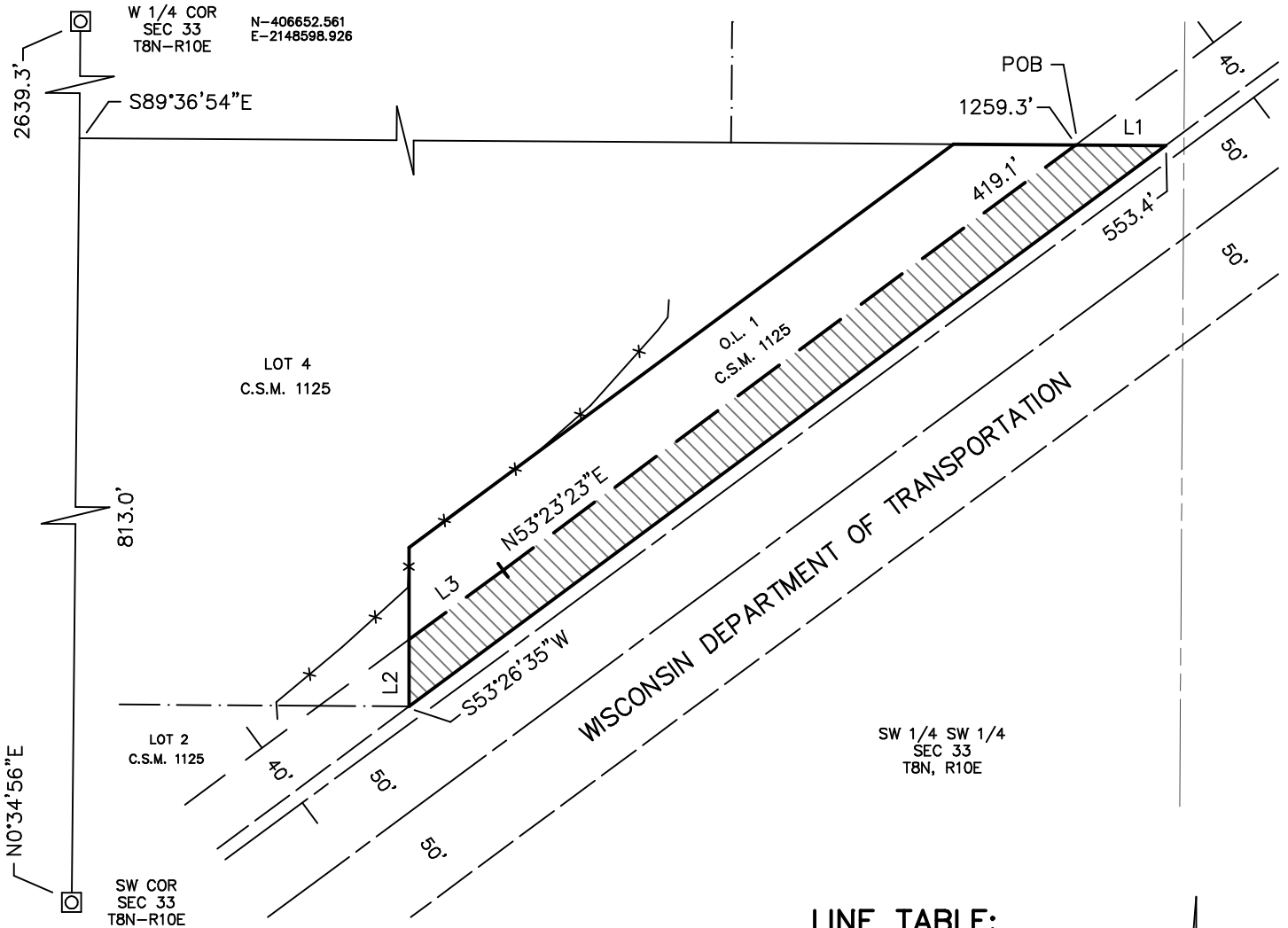

LEGAL DESCRIPTION:

A VARIABLE WIDTH EASEMENT WHICH CROSSES A PART OF THE GRANTOR'S PREMISES, BEING PART OF OUTLOT 1, OF CERTIFIED SURVEY MAP NO. 1125, RECORDED IN VOLUME 4 OF CERTIFIED SURVEY MAPS OF THE DANE COUNTY REGISTER OF DEEDS OFFICE, ON PAGES 436 – 438, AS DOCUMENT NO. 1362057, BEING PART OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER, OF SECTION 33, TOWNSHIP 8 NORTH, RANGE 10 EAST, CITY OF MADISON, DANE COUNTY, WISCONSIN, AS SHOWN ON THE ATTACHED MAP AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 33–8–10;

THENCE N0°34'56"E ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF SECTION 33, 813.0';
